With this new cooperation between PEZA and Advantec, the advanced solar power technology of Advantec will be introduced in the Pampanga Economic Zone to realize both renewable energy supply and CO2 reduction. Specifically saying, it is estimated that the total output capacity will be 2,500 kilowatts, with an annual energy yield of 3.6 million kilowatts.

Simultaneously, with this technology, approximately 1,200 tons of CO2 could be reduced annually.
