Background:

DTI – ARMM is mandated to promote sustainable growth and development of agri-industry as well as micro, small and medium enterprises (MSMEs) and pursue investment promotion to generate jobs in the countryside. One of the strategies that DTI-ARMM is looking into is the industry cluster approach.

Following the success of the Davao Industry Cluster Capacity Enhancement Project (DICCEP), DTI Central Office expanded the model and implemented it as a national program, thus, launching the National Industry Cluster Capacity Enhancement Project (NICCEP) in 2012. Cognizant of the gains that DICCEP and NICCEP have effected in its target clusters (8 for DICCEP and 24 for NICCEP), DTI-ARMM adopts the same framework in ARMM to revitalize the region's economic stance.

The "Development Study on Local Industry Promotion in ARMM" conducted by the Japan International Cooperation Agency (JICA) from 2010-2012, recommended for the promotion of local industries such as agriculture and fisheries, sectors where ARMM commands a comparative advantage.

Through the industry clustering project, stakeholders of related industries in a cluster will be convened to discuss, identify and address hindering factors to their competitiveness. Consequently, with more coordinated efforts from different players of the value chain (producers, processors, consolidators, research institutes, buyers, etc.) of a target industry, the business environment can be improved, generating in turn more investments and creating more jobs.

Module3: Formulation of Implementation Plans (Preparing action projects for implementation)

Module 4: Project Monitoring (Regular review of the action projects)
