### Background:

On 15 October 2012, the Framework Agreement on Bangsamoro (FAB) was signed between the Government of the Republic of the Philippines and the Moro Islamic Liberation Front (MILF). The FAB calls for the creation of the Bangsamoro Transition Commission (BTC), Bangsamoro Transition Authority (BTA) as well as the formation of the Bangsamoro government in 2016.

CCDP-B was formulated by JICA and is expected to promote comprehensive capacity building in order to assist the work of the BTC, BDA and the Bangsamoro Leadership and Management Institute (BLMI) and facilitate smooth transition to BTA and eventually to the new Bangsamoro government.

CCDP-B has four (4) components which aims to address the various needs of the Bangsamoro in the different stages of transition, from the formation of BTC to the creation of the new government.

CCDP-B will be managed by JICA Cotabato Project Office headed by a JICA Expert and counterparts from BTC will be assigned to assist in the formulation, implementation and monitoring of the Project.

# **A. Human Resource Development**

Expected Output: Human resources are developed for the establishment of the Bangsamoro government.

# Approach:

 Development of human resources in the Bangsamoro (Conduct of Human Resources Mapping Survey in the Bangsamoro Communities, formulation of Training Plans and Modules and conduct of trainings for Human Resources of the BTA and the Bangsamoro Government) in preparation and after the establishment of the Bangsamoro Government

# B. Improvement of Public Service Delivery (Sector to be identified)

Expected Output: Delivery of Public Service Delivery is improved Approach:

- 1. Review of Past and On-going Project (before establishment of BTA)
- 2. Enhancement of Service Delivery (after establishment of BTA).

#### C. Institutional and Organizational Building

Expected Output: The creation of institutions and organizations of the Bangsamoro Government is accelerated.

#### Approach:

- 1. Support for the drafting of the Bangsamoro Basic Law (BBL)
- 2. Support in the conduct of public consultations for the BBL
- 3. Preparation for the Establishment of the BTA and Bangsamoro Government (after the submission of the BBL to the Philippine Congress and until creation of the BTA)
- 4. Support for the Organizational Development of the New Bangsamoro government (after the establishment of the BTA)

Expected Output: Bangsamoro Development Plan is formulated. Approach:

- 1. Support for the Formulation of the Transitional Development Plan for 2015-2016
- 2. Support for the Formulation of a Medium-Term Development Plan for 2016-2019
