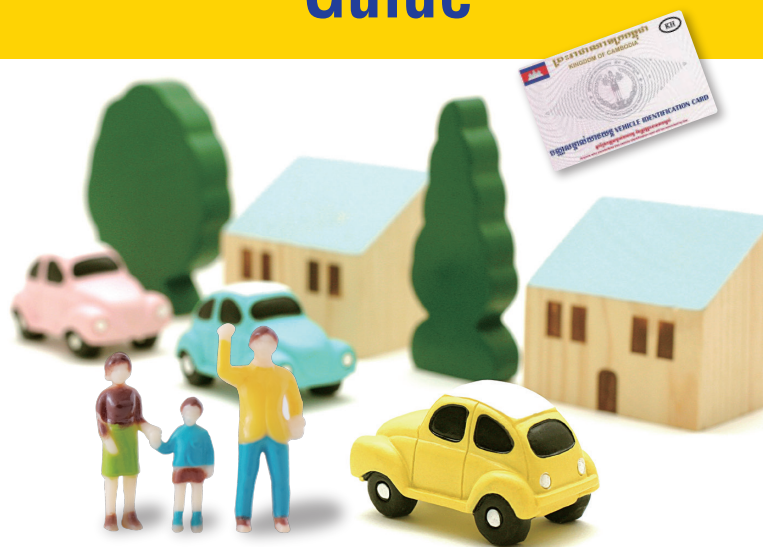

The importance of vehicle registration

- All vehicle owners are obligated to pay road tax.
- If an owner does not transfer or deregister the vehicle, the previous owner may be taxed.
- If a vehicle owner does not deregister a vehicle, the initial owner will bear the full responsibility for penalties regarding illegal vehicle modifications and number plates used incorrectly.
- If an owner does not register the vehicle properly, action may be taken by the police. Examples of punishable offenses are:
 - Driving a vehicle without a vehicle ID card or number plate;
 - Deliberately driving with a fake driver's license, vehicle identification certificate, number plate, or other fake operator's licenses
 - Falsifying a driver's license, vehicle identification certificate or number plate, or other operator's licenses
 - Not returning the number plate or vehicle registration ID card of a discarded vehicle.
- An appropriate vehicle registration can make it possible to trace a stolen vehicle.

■ New vehicle registration application form with pink cover (Original)

* Thumbprint of the vehicle owner or applicant is required.

■ Vehicle owner ID card:

- **Cambodian citizen:** National ID card or family book (Certified copy by local authorities)
- **Foreign national:** Passport with valid visa and residence certificate issued by local authorities (Copy)

■ Certificate of vehicle technical inspection

■ Import tax receipt/customs label (Original)

■ Invoice or bill of sale as proof of purchase (Original)

Transfer registration

Transfer the ownership

If a private or commercial vehicle is to be used as a state, diplomatic, national/international organization, or non-governmental organization vehicles.

All other cases:

■ Transfer registration application form with yellow cover (Original)

* The applicant's address must correspond to the address stated on the applicant's national ID card or in the applicant's family book

■ ID cards for the new vehicle owner and the previous owner:

- **Cambodian citizen:** National ID cards for the new owner and previous owner (Copy)
- **Foreign national:** Passport with valid visa and residence certificate issued by local authorities (Copy)

■ Purchase/sale contract agreement between the previous owner and new owner with thumbprints (Original)

■ Vehicle ID card of the initial owner (Original)

■ Tax stamp receipt issued by the General Department of Taxation (Original)

■ Pencil impression of the vehicle body number or chassis number (Original)

■ Certificate of vehicle technical inspection
