of
MONTHLY MEETING - Dec 2011**

Dien Bien Phu, 3 Jan 2012

I. Purpose & Request

Planning and monitoring monthly activities of the SUSFORM-NOW Project for smooth and effective implementation of the Project Activities.

Request: Having monthly report of implemented project activities and activity plan for next month.

III. Contents

1. Mr. Ky presented Decision on divided mission for members of PMU of SUSFORM-NOW.

2. Discussed results of implementation of working plan of December 2011 and made working plan of January 2012.

1. Approval of VDPs & Ta Leng Plans by Wards/ Communes of Dien Bien Phu city, Dien Bien and Dien Bien Dong districts.

2. Facilitating to change the internal regulation of MIA

Regulation of MIA of Phieng Ban village, Thanh An commune, has been revised from raising porcupine to raising hogs.

3. Continuing provision of LDC news

In the working plan, Ms. Bac, counterpart has responsibility for this activity but in fact all NEWS were made by LDC without Ms. Bac's participation or her opinions.

4. Baseline survey of MIA implementing villages

Mr. Ky: baseline surveys have been implemented at pilot sites already, so it doesn't need to do more.

LDC: Purpose of baseline survey is to identify the changes during implementing project activities.

5. Developing simple procedures and methods of formulation of the plans

Mr. Ky: VFU should be hired to do this activity.

Mr. GOSEKI: TOR has already advertised and sent to VFU, but we haven't received no proposal from VFU.

6. Studying potential of income generation through contractual production.

Now, Woodland Company wants to invest in afforestation at Ta Leng commune and Phieng Ban village.

Mr. Ky: Contents of the contract should be agreed with Commune People's Committee before contacting with the Company.

+ Dien Bien district: Mr. Vinh is in charge.

+ Dien Bien Phu city: Mr. Hiep is in charge.

7. Continuing experimentation of improved stoves

Mr. Mochida: 15 improved stoves were delivered to 3 villages in November 2011. After that monitoring forms were given to villagers for monitoring. Improved stoves are being monitored.

8. Study tour to observe utilization of the improved stove

One study-tour was organized in December 2011 for observing utilization of the improved stove and Biogas at Nhop village, Thuan Chau district, Son La province.

In the working plan, Mr. Thai, counterpart has responsibility for this activity but in fact Mr. Thai didn't receive any detailed implementing plan of this activity, study-tour to Son La, from LDC Expert.

9. Examining the other fuel-wood saving methods

10. Visiting biogas model

One study-tour was organized in December 2011 for observing utilization of the improved stove and Biogas at Nhop village, Thuan Chau district, Son La province.

11. Preparing village workshops

Village Workshops were organized at 8 villages of total 9 villages for getting agreement of Implementation Plans until October 2012.

12. Study on market demand and sales channels of processed product

Studied agricultural products and processed products by farmers. Its report will be done on 19 January 2012.

It is expected that trademark of fermented bamboo shoot with chili for Na Nghe village, Ta Leng commune, Dien Bien Phu city, will be developed.

13. Selection of target groups of introduction of food processing

This activity hasn't been done yet.

14. Requesting 30A budget for Dien Bien Dong District

Dien Bien Dong district will consider and respond in January 2012.

15. Holding village workshops to discuss concrete activity and schedule for forest management and further Livelihood Development activities

Village workshop at Ke Nenh village has been postponed and rescheduled in Jan, but the village informed to postpone again to after Tet.

16. Other contents:

- Developing plan of implementing project activities for January 2012.
- Discussing with investors about supports to afforestation at Ta Leng and Phieng Ban.
- Developing a plan of introduction of food processing

Mr. Thai is in charge.

17. Providing technical support for MIA, if need

- Provide necessary techniques to the villagers by trainings to implement each PA.
- + Conducting Improved stove W/S (Tia Ghenh C): 9 and 16/01/2012. It will start at 9:00AM.

+ Conducting Biogas W/S (Sai Luong): 12-13/01/2012

+ Providing training on animal health and construction of cage

- Shared information of delivery of seed animals at Na Phat A village.

18. Delivering animals for MIA

- Prepare necessary materials for PA.
- Preparing to provide farrowing sow (Sai Luong, Tia Ghenh C) and hogs (Phieng Ban): It is expected to implement in January 2012.

19. Study from the successful models

Have no plan in Jan. 2012.

It is expected to make plans in Jan.

20. Facilitate implementation of PA

- Designing afforestation/ natural regeneration (Ta Leng (Ke Nenh, Phieng Bua), Phieng Ban, Na Phat A.): After TET.

- Publishing an edition of LDC news: Before TET.

- Conducting organic vegetable experimentation: Hang Tro B will be selected to implement this activity in January 2012.

21. Holding a meeting on reviewing and renovating the Monitoring System

It will be organized on 3 January 2012.

22. Monitoring MIA

- Final questionnaire will be done in Jan 2012 and basic living condition of local people in pilot sites is prepared to be surveyed.

- Beginning of Feb 2012, LDC will complete a questionnaire on come in - come out money stream flow at villages.

- Coaching Monitoring Volunteers: Project is advertising to recruit one expert to review the reports of MVs and propose recommendation for improvement.

23. Developing mutual communication system with Supporting Agencies

Workshops on developing mutual system with Supporting Agencies will be held on 5th Jan 2012.

24. Try to use the mutual communication systems with the supporting agencies.

25. Coach Commune/Ward staffs in implementation of activity 1-5 & 1-6: Hasn't been implemented yet.

26. Organize training for province and district/city staffs to guide commune staff to implement activity 1-4, 1-5 & 1-6.

27. Prepare the training of counterparts in Japan: Give comments to the training in Jan 2012.

28. Start to prepare technical manual for the 2nd phase: Contents of technical manual will be developed in Jan 2012.

29. Making project logo: Done

30. Dissemination of the results of the C/P trainings in Japan: Done

31. Observation by JICA VN: Done

32. Introducing activities on the web-site: Going on

33. Revising the list of PMU members and their tasks: Have Decision No.792/QĐ-BQLDA, dated 30/12/2011 of PMU.

34. Revising Progress Report of 2011 and send to JCC members: Mr. Ky has responsibility.

35. Studying on allowance etc. for commune officers.

36. Report regularly (daily and monthly) implementation plans of project activities to leaders of city/district.

37. Send working plan of next week to related agencies on Friday of every week by official letter.

38. Assist Dien Bien PPC to manage Executing agencies to improve cooperation for implementation of Project: Dien Bien DARD - Mr. Ky assisted.

39. PMU makes draft of revised R/D to include ward/commune staffs and Heads of villages in Vietnamese counterparts, send the draft to Dien Bien PPC, then revise the R/D after discussion with JICA Vietnam.

Mr. Goseki: JICA understood importance of participation of Commune staffs in project implementation, but it should be discussed with JICA VN Office whether R/D needs to be revised or not.

Livelihood Development Component NEWS: Before now, LDC News were handed directly to local people. From now, LDC News will be sent by post monthly to local people. It helps local people to know situation of implemented activities.
