Japan International Cooperation Agency (JICA) is a signatory to the Operating Principles for Impact Management (the Impact Principles) since 26 August 2019.

This Disclosure Statement affirms that JICA's policies and practices are aligned with the Impact Principles. This affirmation applies to JICA's Private Sector Investment Finance. Total assets under management in alignment with the Impact Principles is US\$ 6,213 million as of 31 March, 2026. Asset class breakdown is US\$ 4,390 million for loan and US\$ 1,823 million for equity. Geographic breakdown is US\$ 1,786 million for Asia and Pacific, US\$ 1,679 million for Latin America and Caribbean, US\$ 421 million for Middle East and Europe, US\$ 201 million for Africa, and US\$ 2,126 million for regionally unclassified investments.

The information contained in this Disclosure Statement has not been verified or endorsed by the Global Impact Investing Network ("the GIIN") or the Secretariat or Advisory Board. PRINCIPLE 1:

Define strategic impact objective(s), consistent with the investment strategy.

The Manager shall define strategic impact objectives¹ for the portfolio or fund to achieve positive and measurable social or environmental effects, which are aligned with the Sustainable Development Goals (SDGs), or other widely accepted goals. The impact intent does not need to be shared by the investee. The Manager shall seek to ensure that the impact objectives and investment strategy are consistent; that there is a credible basis for achieving the impact objectives through the investment strategy; and that the scale and/or intensity of the intended portfolio impact is proportionate to the size of the investment portfolio.

- JICA is an Incorporated Administrative Agency of the Government of Japan and one of the largest bilateral agencies for international cooperation.
- JICA's operations are governed by "Act of the Incorporated Administrative Agency-Japan International Cooperation Agency" (Act No. 136 of December 6, 2002, hereinafter referred to as "JICA Act") and Article 13 (1) (ii) (b) and (c) of the JICA Act specify scope of JICA's Private Sector Investment Finance (hereinafter referred to as "PSIF") .
- JICA only provides its finances "which contribute to the Developing Area²'s economic and social development" as stipulated in the JICA Act.
- In addition, the JICA's Position Paper on SDGs dated September 8, 2016 is publicly disclosed, which set three pillars of JICA's cooperation toward achieving the SDGs and one of the pillars mentions that JICA will play a key role in achieving 10 goals* of the 17 SDGs making use of Japan's own experience in socio economic development of Japan and in development cooperation for the international community.
10 goals: zero hunger, health, education, water/sanitation, energy, economic growth, industry/infrastructure, sustainable cities, climate actions, forests/biodiversity
- Therefore, JICA invests in the Development Projects, which contribute to achieving SDGs.

PRINCIPLE 2:

Manage strategic impact on a portfolio basis.

The Manager shall have a process to manage impact achievement on a portfolio basis. The objective of the process is to establish and monitor impact performance for the whole portfolio, while recognizing that impact may vary across individual investments in the

portfolio. As part of the process, the Manager shall consider aligning staff incentive systems with the achievement of impact, as well as with financial performance.

- According to Article 14 (3) of the JICA Act, JICA performs the operations of PSIF "only when the project plan for Development Projects" is "appropriate, and there is a prospect of their accomplishment," which result in achieving impact as well as financial performance.
- JICA ensures impact achievement and financial performance on a portfolio basis as well as for individual investment of PSIF, through a monitoring process that includes periodic reporting, field inspections, and participation in board of directors (in case of equity investment).
- PSIF projects are assessed from a portfolio-wide perspective to identify common risks, emerging trends, and lessons learned, and to support strategic portfolio management and decision-making. The findings are reported annually to JICA's board of directors.
- Furthermore, the Risk Management Committee for Finance and Investment Account and Board of Directors of JICA periodically monitors the portfolio of PSIF from the perspectives of both financial aspects and developmental impact. The aggregated development impact data of PSIF is published on the JICA website.
- In addition, JICA's mission to achieve the impact is at the core of our operating strategy and forms a basis for our annual operation plans and target setting for management, departments, and all staff.
- Staff incentive systems are aligned with the achievement of impact because performance evaluation of all staff is conducted based on their contribution to achievements of the annual operation plans which include development impact targets.
- Thus, JICA manages impact of operations of PSIF on a portfolio basis.

PRINCIPLE 3:

Establish the Manager's contribution to the achievement of impact.

The Manager shall seek to establish and document a credible narrative on its contribution to the achievement of impact for each investment. Contributions can be made through one or more financial and/or non-financial channels.³ The narrative should be stated in clear terms and supported, as much as possible, by evidence.

- The JICA Act, by its Article 14 (2), requires that JICA perform the PSIF "only when the

lending of funds or investment by ordinary financial institutions on ordinary terms is deemed difficult", as well as Article 14 (3) that JICA may perform the operations of PSIF "only when the project plan for Development Projects" is "appropriate, and there is a prospect of their accomplishment."

- In addition, JICA follows OECD-DAC requirements to examine and disclose financial and/or value additionality of each PSIF project.
- Also, JICA establishes the Project Evaluation system, in which for every investment of PSIF JICA conducts ex-ante evaluation in accordance with JICA Guideline for Project Evaluation, which defines effectiveness and impact of the investment of PSIF, and the result of ex-ante evaluation is publicly disclosed in accordance with confidentiality requirements. Thus, for every investment, JICA has to seek its contribution to the achievement of impact and clearly describe its contribution.
- JICA provides research, dispatch of experts, training, provision of materials and equipment, etc., in order to expedite the progress of existing Loan and Equity projects as well as increase its development impact, if appropriate, based on Article 13, Paragraph 1, Item 8 (research and study) or Item 9 (incidental services) of the JICA Act. In addition, JICA seeks to maximize development impacts through the coordination between private sector financings and the assistances to sovereign entities as JICA provides technical cooperations, grants and concessional financings to sovereign entities. JICA's intervention for value addition includes building IMM capacity, impact/ESG expertise and network, technical assistance/advisory, mobilizing external/private/other funding sources, etc.

PRINCIPLE 4:

Assess the expected impact of each investment, based on a systematic approach.

For each investment the Manager shall assess, in advance and, where possible, quantify the concrete, positive impact⁴ potential deriving from the investment. The assessment should use a suitable results measurement framework that aims to answer these fundamental questions: (1) What is the intended impact? (2) Who experiences the intended impact? (3) How significant is the intended impact?⁵ The Manager shall also seek to assess the likelihood of achieving the investment's expected impact. In assessing the likelihood, the Manager shall identify the significant risk factors that could result in the impact varying from ex-ante expectations. In assessing the impact potential, the Manager shall seek evidence to assess the relative size of the challenge addressed within the targeted

geographical context. The Manager shall also consider opportunities to increase the impact of the investment. Where possible and relevant for the Manager's strategic intent, the Manager may also consider indirect and systemic impacts. Indicators shall, to the extent possible, be aligned with industry standards⁶ and follow best practice.⁷

- The JICA Act, by its Article 14 (2), requires that JICA perform the PSIF only when the lending of funds or investment by ordinary financial institutions on ordinary terms is deemed difficult", as well as Article 14 (3) that JICA may perform the operations of PSIF "only when the project plan for Development Projects" is "appropriate, and there is a prospect of their accomplishment."
- JICA conducts ex-ante evaluations prior to the project implementation to confirm needs and priorities of the projects and measure the expected outcomes from perspective of the Six DAC Criteria⁸ in accordance with JICA Guideline for Project Evaluation.
- Therefore, JICA, when performing operations of PSIF, assesses the expected impact and beneficiaries of each investment quantitatively and qualitatively, based on JICA's Project Evaluation system. In the due diligence (DD) process, JICA also examines the potential positive impacts that may be generated through the investment, while identifying key risk factors that could affect the achievement of the expected outcomes. These risk factors are analyzed primarily from the perspective of factors that may influence the overall viability and performance of the project, and corresponding mitigation and management measures are considered as part of the investment assessment, thereby supporting informed decision-making and helping to enhance the likelihood of achieving the intended developmental impact.

PRINCIPLE 5:

Assess, address, monitor, and manage potential negative impacts of each investment.

For each investment the Manager shall seek, as part of a systematic and documented process, to identify and avoid, and if avoidance is not possible, mitigate and manage Environmental, Social and Governance (ESG)⁹ risks. Where appropriate, the Manager shall engage with the investee to seek its commitment to take action to address potential

gaps in current investee systems, processes, and standards, using an approach aligned with good international industry practice.¹⁰ As part of portfolio management, the Manager shall monitor investees' ESG risk and performance, and where appropriate, engage with the investee to address gaps and unexpected events.

- JICA establishes the “Environmental Policy” and the “JICA guidelines for Environmental and Social Considerations”, which require assessment, monitoring and management of potential negative impacts at the level of international standard. According to JICA's guidelines for environmental and social consideration, for each investment, it seeks to support and examine appropriate environmental and social considerations undertaken by project proponents etc. to avoid, minimize, reduce, mitigate, or compensate for potential environmental and social risks of PSIF operations, prior to approval of the investment and during operations.

- Also, JICA establishes its internal policy of integrity check and conducts integrity due diligence of PSIF investees for each investment to avoid and mitigate governance and integrity risks, prior to approval of the investment.
- After JICA monitors compliance of ESG risks by the investee and when it is confirmed that ESG risks might appear in monitoring phase, the division will take necessary measures.
- Thus, JICA assesses and monitors ESG risks and its compliance by the investee for every investment of PSIF.

PRINCIPLE 6:

Monitor the progress of each investment in achieving impact against expectations and respond appropriately.

The Manager shall use the results framework (referenced in Principle 4) to monitor progress toward the achievement of positive impacts in comparison to the expected impact for each investment. Progress shall be monitored using a predefined process for sharing performance data with the investee. To the best extent possible, this shall outline how often data will be collected; the method for data collection; data sources; responsibilities for data collection; and how, and to whom, data will be reported. When monitoring indicates that the investment is no longer expected to achieve its intended impacts, the Manager shall seek

to pursue appropriate action.¹¹ The Manager shall also seek to use the results framework to capture investment outcomes.¹²

- JICA ensures impact achievement and financial performance on a portfolio basis as well as individual investment of PSIF, through monitoring process of reporting, field inspection and participation in board of directors (in case of equity investment), in order to monitor the progress of the expected impact determined in ex-ante evaluation and, in case of necessity, to take necessary actions to achieve the impact. For each project, JICA agrees with borrowers and investees about development indicators and its related information disclosure, responsible division monitors the progress of the expected impact. In addition, on an annual basis, JICA aggregates the performance of these impact indicators using quantitative data and discloses the results on its website to ensure transparency and accountability.
- JICA conducts ex-ante/ex-post evaluations on all projects costing 200 million yen or more. During the ex-post evaluation, JICA evaluates projects in line with the international criteria for evaluating development assistance set by the OECD-DAC (DAC Evaluation Criteria), and aims to utilize the evaluation results. The ex-post evaluation will usually be conducted 2 years after the completion of the development projects (ex. construction of infrastructure). For projects costing over one billion yen, JICA strives to ensure the objectivity and transparency of the evaluation results by incorporating evaluations conducted by external third parties (external evaluations). External evaluations are conducted by external evaluators such as development consultants that specialize in evaluations.

- Because JICA covers both sovereign and private financings, IRIS+, HIPSO or the Joint Impact Indicators (JII) do not perfectly fit our coverage of operation. Thus, JICA uses our own comprehensive sets of development impact indicators which are intended to capture development impacts of both public and private sector investments while refers to such internationally recognized indicators as IRIS+, HIPSO or JII as far as it is appropriate.

- Therefore, JICA has monitoring process to confirm the progress of expected impact to be achieved in every investment.

PRINCIPLE 7:

Conduct exits considering the effect on sustained impact.

When conducting an exit,¹³ the Manager shall, in good faith and consistent with its fiduciary concerns, consider the effect which the timing, structure, and process of its exit will have on the sustainability of the impact.

- Article 13 (1) (ii) (b) of the JICA Act, JICA performs operations of “the making of the capital contributions to such persons when there is a special necessity in order to effectuate Development Projects”, which is equity investment, and JICA’s Statement of Operational Procedures requires exit policy of equity investment prior to its approval, based on consent of the investee.
- One of the triggers to decide exit of JICA’s equity investment in the exit policy is that the investee or Development Projects achieves sustainability from the viewpoint of financial and developmental impact expected in the ex-ante evaluation.
- Thus, JICA exits from its equity investment in accordance with the exit policy set with the investee when sustainability of the investment is achieved.

PRINCIPLE 8:

Review, document, and improve decisions and processes based on the achievement of impact and lessons learned.

The Manager shall review and document the impact performance of each investment, compare the expected and actual impact, and other positive and negative impacts, and use these findings to improve operational and strategic investment decisions, as well as management processes.

- JICA conducts ex-post evaluations to evaluate completed projects comprehensively in accordance with JICA Guideline for Project Evaluation and examine whether the project’s effectiveness, impact and sustainability will continue after project completion. Lessons learned from the evaluation results help in improving subsequent projects, formulating new projects and considering fundamental cooperation strategies.
- Thus, JICA continuously improves decisions and processes based on the result of ex-post evaluation and portfolio review meeting, utilization of lessons learned from previous investments of PSIF.

PRINCIPLE 9:

Publicly disclose alignment with the Impact Principles and provide regular independent verification¹⁴ of the alignment.

The Manager shall publicly disclose, on an annual basis, the alignment of its impact management systems with the Impact Principles and, at regular intervals, arrange for independent verification of this alignment. The conclusions of this verification report shall also be publicly disclosed. These disclosures are subject to fiduciary and regulatory concerns.

- JICA receives audits from independent auditors. Auditors certify that the business operations as a whole, including PSIF, are properly conducted in compliance with laws and regulations and efficiently and effectively conducted in order to achieve objectives as stipulated in the JICA Act.
- The auditors are independent because they are appointed by the Minister of Foreign Affairs and can submit their opinion directly to the minister, if necessary, based on the provisions set forth in Article 19 and 20 of Act on General Rules for Incorporated Administrative Agencies.
