Important Notice:

This project involves the reconstruction of the Tagabe Bridge and associated infrastructure damaged by the earthquake that struck Vanuatu on 17 December 2024. In view of the urgent nature of the project, a fast-track approach has been adopted to shorten the period from the outline design stage to the selection of the successful Bidder.

Accordingly, Bidders are kindly requested to acknowledge that the drawings, quantities and other documents distributed following the bid announcement are based on the outline design. Please submit your bid on the basis of the drawings, quantities and related documents revised and issued upon completion of the detailed design, which will be provided by 16 January 2026.

The principal modifications are anticipated to concern the structural dimensions of the concrete bridge as well as the quantities of all the works.
