ネパール国、インフラ交通省道路局は、日本の無償資金協力による「洪水被害を受けたシンズリ道路緊急復旧計画」の入札を公示します。シンズリ道路で洪水被害を受けた一部区間における道路、補強土壁、排水構造物及び道路付属施設の建設を実施するもので、詳細は以下のとおりです。

1. The Government of Nepal has received a grant from the Japan International Cooperation Agency (JICA) towards the cost of the Project above and intends to apply part of the grant towards payments under the Contract above.
 2. The Client above now invites sealed Bids from eligible Bidders for the construction and completion of the project which consists of construction of road with a length of 2.9km, a lane width of 7.0m (3.5m x 2) and shoulder width of 3.0m (1.5m x 2) including reinforced earth wall, stone masonry wall, stone pitching, drainage, and road furniture works.
 3. Bidding will be conducted through procedures in accordance with the applicable Procurement Guidelines for the Japanese Grants, and is open to Bidders who meet qualifications defined in the Bidding Document.
 4. Abstract of qualifications of the bidders are as follows.
 - To have minimum average annual turnover of 50 billion JPY within the last 3 years;
 - To have at least 1 experience of civil engineering or building construction project in Nepal with the contract price not less than 1 billion JPY during the last 10 years, or at least 4 experience of civil engineering or building construction project in the South Asian region* other than Nepal with the contract price not less than 1 billion JPY during the last 10 years
 - Contractor's Representative in situ shall have at least 1 experience in civil engineering or building construction project in Nepal with a duration of 6 months or more during the last 10 years or at least 2 experience in civil engineering or building construction project in the South Asian region* other than Nepal with a duration of 6 months or more during the last 10 years
- * The term South Asian region, as used herein, refers to the six countries listed on the website of the Ministry of Foreign Affairs of Japan, excluding Nepal: India, Sri Lanka, Pakistan, Bangladesh, Bhutan, and Maldives.
