

Participation Agreement for Internship Program
with the Japan International Cooperation Agency

To: Japan International Cooperation Agency (hereinafter referred to as “JICA”)

- I fully understand the objectives of this Internship Program and intend to devote myself to promotion of mutual understanding and to learning of the technologies/knowledge provided by an organization/company at which I will participate in the program (hereinafter referred to as “Organization/Company”).
- I shall maintain the confidentiality of confidential information disclosed by the Organization/Company during the internship and shall not disclose or divulge the information to a third party during the internship period and even after that. In case I pronounce a thesis which includes the confidential information, I will inform the Organization/Company of it in advance and will obtain officially written consent from the Organization/Company.
- The personal information that I receive from the Organization/Company will be used only within the scope of the purposes that are set forth below, and, therefore, I will not, except when the disclosure of such information is required by law, or unless there are other legitimate reasons, use such information for purposes other than those for which it was originally intended:
 - (1) To be used for the distribution of program and examination related documents and materials as well as related communications, and to be used for contacting the applicant;
 - (2) To be used for the operation and management of programs and examinations that we conduct; and
 - (3) To be used, aside from the above, for a specific purpose for which the applicant has given prior consent.
- The personal information that I receive from the Organization/Company may, from time to time, be disclosed to an extent that is deemed necessary in order to enable a seminar instructor, outsourcing service provider, or other such parties to carry out a program or examination, provided that I have entered into a confidentiality agreement with them.
- During my stay as a trainee on the Internship Program, I shall not participate or engage in any other program or work unrelated to this Internship Program.
- During the Internship Program, I shall obey the laws and regulations in Japan and will not engage in criminal activities or take any immoral behavior. I understand that the Organization/Company will not bear any responsibility in cases where any crime or other problem that I could essentially have avoided occurs as the result of illegal action or negligence on my part.
- I shall observe the rules and regulations of the Organization/Company during my program. If special attention must be paid so as not to cause damage to the Organization/Company's properties, facilities or equipment, I shall follow the instructions provided by the Organization/Company.
- After I complete my training at the Organization/Company, I shall submit a Report of Completion of Internship Program to both the Organization/Company and JICA.

- I agree that, in cases where I cause damage to the Organization/Company intentionally or due to my being heavily intoxicated, my program will be canceled automatically and I shall be subject to disciplinary punishment, and may result in the case that I shall leave Japan to return to my country immediately.
- I shall not request monetary assistance from the Organization/Company in any circumstances.
- During my stay at the offered accommodation facility, I shall respect the rules and customs of such facility as well as the other residents in the same manner as they do. I am aware that my staying and living in Japan, and my devoting myself to promotion of mutual understanding, based on a deep understanding of the spirit of global fraternity as well as on good intentions, is one of the prime objectives of this Internship Program.
- The Organization/Company shall not be under any legal liability in the event that the continuous implementation of the program becomes impossible due to any cause not within its control, including, without limitation, factory lockouts, strikes or other industrial disputes, riots, civil commotion, epidemics, wars, confiscation of assets for public needs, embargoes, or natural disaster.
- I will not bring my spouse or my family members to the place where the Internship Program is implemented during the program.
- My supervisor agreed that I participate in this Internship Program.
- I declare that I am healthy enough to complete this Internship Program, and I do not have any health issues such as severe allergies, physical disabilities and serious diseases.
- The confidentiality pledge, which I may enter into with the Organization/Company shall not be affected by the provisions of the preceding paragraphs.
- If I cause damages or losses to the Organization/Company or any third party intentionally or negligently, I shall be liable to compensate such damage or losses.
- I hereby testify that I have read and given my consent to the terms and conditions of this written oath. If I violate any of the provisions above, I consent to my being required to leave Japan promptly.
