On his inauguration speech in January 1st 2003, President Luis Inácio Lula da Silva declared that Brazil has an outstanding historic debt towards Africa and all along his tenure that continent will be a priority of Brazilian foreign policy, as well as all the ensemble of South-South relations. As a response to that challenge posed, the Ministry of External Relations, through the Brazilian Cooperation Agency – ABC, developed a set of principles, actions and mechanisms that resulted in the so called Brazilian South-South Technical Cooperation (SSTC). Recently, during the African Union Summit in Addis Ababa, President Dilma Rousseff reasserted Brazil's committment towards Africa, promising to elevate cooperation, trade and investments relations between our continents to a higher level never reached before.


