CAPACITY DEVELOPMENT PROJECT FOR AIR POLLUTION CONTROL PHASE 2

Air pollution in urban areas of Kosovo has become a serious environmental problem due to emissions from the lignite-fired power plants, residential stationary sources such as heating and cooking, as well as vehicles, and its effect on human health is a major concern. In addition, compliance with the ambient air quality standards of the EU is also required, but Kosovo is lagging in this aspect as well.

Furthermore, Kosovo has strongly requested assistance for the capacity development, and support for establishing necessary systems and structures to help fulfill the EU obligations, which Kosovo aspires to access to in the future. Under these circumstances, JICA has continued the effort to support capacity development to control air pollution in Kosovo and started implementation of the "Capacity Development Project for Air Pollution Control in Kosovo Phase 2" with the aim to develop capacities for air quality management based on technical evidence by creating future scenarios and evaluating the effectiveness of measures based on this scientific evidence.

Since 2011, JICA has supported improvements of waste management including donation of collection trucks in Prizren Municipality and four municipalities namely Malisheva, Suhareka, Rahovec, and Dragash, The measures taken in the Phase 1 project within the framework of the "Prizren model" include establishing a department in charge of waste management and allocating appropriate personnel as well as introducing a waste tax, allowed Prizren to improve its waste management capacity. On the other hand, in the four target municipalities, which were also included as project sites in the Phase 1 project, similar results could not be achieved. Against this background, the objective of the Phase 2 project has been set to strengthen the waste management capacity of MESPI and four target municipalities

PROJECT ON CAPACITY BUILDING FOR DISASTER RISK REDUCTION THROUGH NATIONAL FOREST FIRE INFORMATION SYSTEM (NFFIS) AND ECO-DRR

The occurrence of forest fires in Kosovo not only affects the reduction of forest resources and biodiversity but delays the recovery of forests and may also lead to the occurrence of other natural disasters, such as soil erosion. Therefore, early detection and countermeasures against forest fires are very important for minimizing damage, and thus a system that monitors the whole country using satellite images from the sky is effective.

To tackle this issue, Kosovo has requested support from the Japanese government for the implementation of the "Project on Capacity Building for Disaster Risk Reduction through National Forest Fire Information System (NFFIS) and Eco-DRR". National Forest Fire Information System (NFFIS) that has been introduced in Kosovo is an integrated Web-GIS system for fire prevention and early warning, which allows sharing information with relevant agencies. On the other hand, to realize a sustainable and resilient environment and to reduce disaster risks, the sustainable management, conservation, and restoration of ecosystems – known as "Eco-DRR (Ecosystem-based Disaster Risk Reduction)" is indispensable.

The purpose of the Project is to strengthen the capacity of government official in the prevention and mitigation of forest fires and other natural disasters through the establishment of NFFIS and Eco-DRR.

THE PROJECT FOR CAPACITY Development of Radio Television of Kosovo (RTK) Phase 2

The goal of this project was providing assistance to RTK to enable accuracy, impartiality, and fairness in its programming, thereby providing a bridge to communication in this multiethnic country so that the programs of RTK are watched by a wide range of people in Kosovo. This was to be done with Japan's public media organization sharing its accumulated knowledge in technology, program production, and in the gathering and reporting of news.

The Project activities includes establishing Prizren and Mitrovica Regional offices, developing internal criteria for fair and unbiased program production, and utilizing digital archive system. The new regional offices allow for more in-depth regional coverage and the shaping of this information into news and programs. The project phase 3 is planned to start in 2024.
