JICA Development Studies Program (JICA-DSP)

Various universities, in collaboration with JICA, have established JICA-DSP among the graduate school degree courses they offer. JICA-DSP consists of class subjects pertaining to the development experience of modern Japan (including the experience of Japan's own development and of its cooperation with other countries through ODA). This program offers JICA scholars a chance to deepen their understanding of Japan's development experience in the respective academic fields.

Graduate School of International Cooperation Studies (GSICS)

The GSICS aims to cultivate the capabilities of students with excellent potential and enthusiasm to pursue careers in international fields, to develop an international community. Education and research activities at GSICS emphasize the development of both expertise and multidisciplinary knowledge. This program provides insights into the Japanese development experience and the role of Japanese ODA in developing countries. It aims at providing a strong knowledge and reference base to students, to enable them to formulate an appropriate development policy, and play a central role in implementing it in their countries.

COURSE SUBJECTS

Human Capital Development

- Outline of the Japanese education experience and the education policies from the Meiji era to present day
- Reform and development of Japanese education in the context of economic growth and economic development of Japan

Law and Economic Development

- The redesign of original civil and commercial law (which was designed for economic development) to coordinate with social policy issues through the accumulation of case law and special law
- The study of institutional design that can be harmonized with sustainable development orientation for Asian countries while learning from Japan's development experience

Local Government

 How the Japanese local governments dealt with various problems including pollution and welfare policies from the historical perspective

Disaster Risk Management

- Scientific and technical research on disaster prevention and mitigation
- The background, research content and efforts to reduce disasters related to the Japanese experience

Post-disaster Recovery Planning

- Introduction to JICA's reconstruction assistance and disaster prevention activities implemented in foreign countries
- Application of Japanese knowledge about disaster reduction and reconstruction overseas
