## JICA Development Studies Program (JICA-DSP)

Various universities, in collaboration with JICA, have established JICA-DSP among the graduate school degree courses they offer. JICA-DSP consists of class subjects pertaining to the development experience of modern Japan (including the experience of Japan's own development and of its cooperation with other countries through ODA). This program offers JICA scholars a chance to deepen their understanding of Japan's development experience in the respective academic fields.



## School of International and Public Policy

Hitotsubashi University has established a professional graduate school, School of International and Public Policy, in collaboration with the Graduate School of Law and Economics, and aims to foster leaders who are able to identify relevant public policy problems and find their solutions.

In achieving this goal, this course will be guided by the following four basic principles: 1. Professional education based on the foundation of state-of-the-art research, 2. Foster leadership with multiple viewpoints through crosscutting analysis, 3. Emphasis on multi-faceted and practical policy analysis, 4. Foster leaders who will play an active role in the world and build a research centre in the Asia-Pacific region.

## PROGRAM OUTLINE

This program is an immersive, experiential program, in which students experience the process of industrialization and modernization of a country through simulation. Understanding the problems caused by modernization, and analyzing the successes and failures of the political responses to these problems, enables international students from developing countries, particularly, to visualize the modernization process of their countries. They are then able to contribute significantly to the strategic and policy making processes.

#### Japan's Fiscal and Monetary Policy Making

• Review of reasons for the success and failure of Japan's domestic fiscal and monetary policies to understand the transformation of the Japanese economy
