## **Status Quo and Challenges**

- Doubling population (2020:1.3 bn, 2050: 2.5bn), need to cope with rapid urbanization.
- Regional Integration contributes to growth, peace and stability thru ensuring flow of goods, people, etc. Lack of production value chain, skilled labor, and infrastructure.

### **Direction of Activities towards TICAD-8**

#### Overview:

Pursuing maximum impact and value-for-money in new initiatives, continued commitment to existing initiatives with improvements, and legal foundation to offer direct support to RECs

- Deepening regional economic integration, challenging new issues: Keywords "connecting corridors" "secure corridors" "free & open smart city" "trade facilitation & security, disease control, IT"
- Establishing long-term cooperation with AU and RECs (EAC, UEMOA, etc.) ii.
- iii. Co-financing with AfDB (EPSA), WB, IOM, etc.
- iv. Partnering with the private sector and other diverse actors

#### (1) Integrated Corridor Approach 2.0(PIDA-PAP2)

- Emphasis on software and knowledge support (global logistics research, road asset management, etc.)
- ii. Continued support to 3 priority corridors (prioritized resource allocation)
- iii. Supporting AU's PIDA-PAP2 (corridor development)
- iv. Utilizing recommendations from automobile industry promotion survey and Home Grown Solutions (HGS) Accelerator Program

#### (2) Free and Open Smart City Development (Quality Infrastructure)

- Abidjan as showcase of urbanization (DX, data utilization, and start-ups; consider support to install City OS in the future)
- Proposing showcase model infrastructure (such as urban transportation projects) together with M/P development
- iii. Promoting DX in public transport (TOD development initiative, promoting DX such as MaaS)
- iv. COVID-19 response in urban areas

#### (3) Continental Trade Facilitation and Border Management (Accelerating Implementation of AfCFTA, Promoting OSBP)

- Enhancing OSBP functionality (comprehensive support for trade facilitation, border management and disease control)
- AfCFTA support (based on ASEAN experience)
