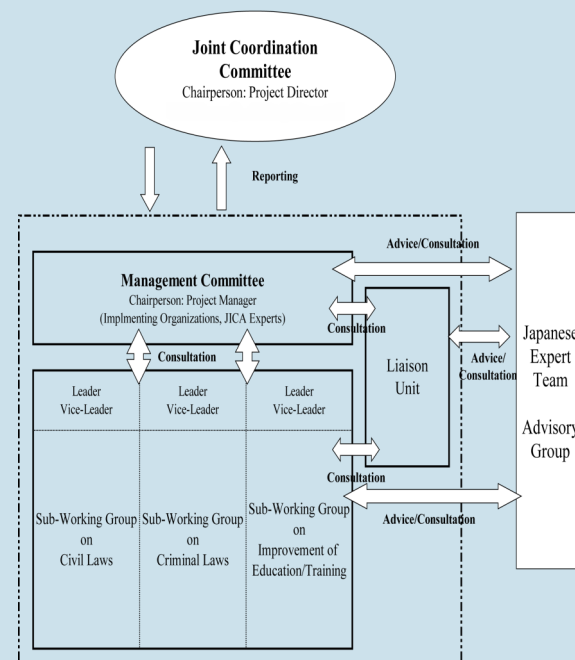

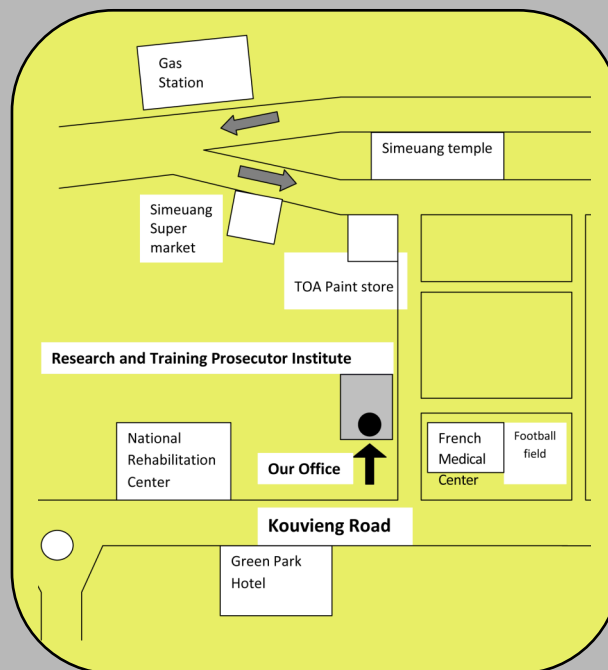

The Project for Promoting Development and Strengthening of the Rule of Law in the Legal Sector in Lao PDR

Background

On the basis of the Lao government's master plan of building the country to be a state governed by the rule of law and the results of evaluations of prior projects "Project for Human Resource Development in the Legal Sector" Phase I & II, which were implemented from 2010 to 2018, JICA and the four Lao authorities concerned, such as Ministry of Justice, People Supreme Court, Office of Supreme People's Prosecutor, National University of Laos, have seamlessly started new J-ROL Project.

Project Purpose

The core human resources of legal and judicial sector acquire abilities to study legal theories, to implement and enforce basic laws based on legal theories and to improve laws and practices, share outcomes of the study with relevant officials of the sector and plan sustainable structures to continue these activities by themselves, and the trainers and lecturers of legal education and training sector acquire abilities to train high quality legal practitioners.

Working Group Activities

The project formulates several Sub-Working groups, such as **Civil Law SWG / Criminal Law SWG / Education and Training Development SWG** which are composed of Lao officials from different organizations to research Lao laws and to make materials based on their research. Japanese legal experts always support these activities.



Training in Japan

Several hundred Lao officials have visited Japan and learned Japanese legal system built by harmonizing advanced western legal system and actual Japanese society.



Civil Code Drafting

The first Civil Code in Lao history, which the JICA project supported drafting work, was approved by the National Assembly on 6th December 2018. The project continues to assist Lao government to disseminate it to the society.
