# Observations and recommendations for AKAC

- The Conference can be held both virtually and in person to give access to more people
- Invitations sent to all Kaizen Institutes, NPOs, private sector consultants in Africa
- Marketing/communication about AKAC to similar international conferences, extend invitations to those organizers to increase partnerships opportunities and mutual learning
- The date of the conference should be well known to the organizing committee at least two years in advance to assist with the preparation.
- Establish a list of organizing countries – at least two countries assigned for next conference and decision validated during the Annual Conference
- Presentation by different presenters/speakers can be shared with NPOs/Kaizen Institutes
- Cultural evenings and entertainment, site seeing, study tours can be included (when conferences can be held physically)
- Awards constitute a strong part of the Program
- Continuous Professional Learning Units Awarded for attendance to the conferences
- Community of Practices Formed or Annual General Meetings/Core Council meetings held during the Conference
- Registration fees from participants can be considered and sponsors from the private sector to fund the event

# Observations and recommendations for AKA

- Motivate nominees and nominators
- Name of the Award
- A standard definition of participating organisations
- Evaluation criteria :periodical reviews of criteria and weightings; reviewing the evaluation criteria based on the standard curriculum and certification system to be developed under the Africa Kaizen Initiative
- Assessment of projects: Year-on-year performance improvement v/s comparative performance assessment



# Observations and recommendations for AKA

- Diversity of Awards in Africa and AKA becoming the forum where the best awardees represent their country at continental level
- Marketing/Dissemination: promotional videos, media coverage, logo used by winners
- Networking: Develop a network of certified award evaluators, Encourage partnership between AKA winners and Nominators



# Institutionalization of AKAC and AKA

- **Establish a sustainable institutional setting**

WG 4 proposes to have a **feasibility study** on the options below

Option 1: Substantive support to AUDA-NEPAD from African countries

Option 2: Select one of the Kaizen promoting institutes/NPOs in Africa through a competitive process and entrust it to act as secretariat

Option 3 (long term): Set up a Productivity/Quality/Kaizen Organisation of African Countries in Africa






# Highlights from interviews

## **AUDA-NEPAD**

- The focal point from a policy point of view, in mobilizing and organizing member states as well as facilitating learning and exchange across various member states
- Advocating the domestication and scaling up of Kaizen by African countries

## **Entrust a Kaizen Institute/NPO as secretariat**

- Set up on acceptance from the countries, recognized, legitimate, having a regional, continental credibility and legitimacy
  - Need to develop and manage the right process
- 

# Highlights from interviews

- Selection of an existing institution promoting Kaizen in Africa which can take the responsibility of the AKI/AKA/AKAC for 3-4 years until we can go to continental level
  - Write the proposal with Background, objectives etc.
  - Develop the criteria for the selection of that institution (ex: qualified and professional institution, stable, experience etc.)
  - Invite all Kaizen Institutes/NPOs in Africa for Expression of Interest
  - Evaluation and selection
  - Continuous transfer of knowledge from JICA to the selected institution/ training and development of staff

# Highlights from interviews

- In the long term : Study, expand and communicate and set up an African Productivity Organisation; a self-financing, non-profit organization annexed to AUDA NEPAD with a very lean structure
