On behave of representative of LS-6 project is pleased to inform that during 23-25 Oct 2013, the project had paid first cash of 217,869,720 Kip for compensation to the impacted villagers/household in Savannakhet province, than the 2nd cash of 203,086,010 Kip had been paid during 13-17 Feb 2014 and during 22-23/Oct /2014 the 3rd cash of 791,205,793 kip was paid for impacted villagers in Saravan province. In addition, during 21-24/12/2014, the 4th cash of 156,569,266 kip was paid completely for compensation.

Savannakhet province:

- ➤ Line route of transmission line: The compensation amount about 608,127,524 Kip had been paid completely /covered 406 households of 43 villages in 4 districts of Kaisonem, Champhone, Xaiphouthong and Songkhone
- About 24,141,571 Kip had been paid completely for 15 additional impacted households.
- The total impacted household of Savanakhet province is counted/covered about 421 households in 43 villages and the total compensation amount is about 632,269,095 *Kip*.

Saravan province:

- The line rout of transmission line made impact for 419 household in 47 villages of 3 districts of Nakhonepheng, Vapi and Saravan districts and the compensation amount was completely paid in total of 686,215,558 Kip
- The additional impacted household of Saravan province is 60 households and the total compensation amount is counted about 50,246,136 Kip.
- The total impact household in Saravan province is 469 h/h 47 village and paid amount is counted of 736,461,694 Kip.
 - The total compensation amount of two provinces is 1,368,730,789 Kip.

The handover ceremony for compensation was successfully organized and cooperated with Join Coordinating Committee of the Project including local provincial government officers, villagers. Please refer to attachment of photos for further information.
