# MINUTES OF DISCUSSIONS ON MASTER PLAN STUDY FOR PORT SECTOR IN THE REPUBLIC OF IRAQ

# AGREED UPON BETWEEN GENERAL COMPANY FOR PORTS OF IRAQ, MINISTRY OF TRANSPORT AND JAPAN INTERNATIONAL COOPERATION AGENCY

In response to the official request of the Government of the Republic of Iraq to the Government of Japan, the Japan International Cooperation Agency (hereinafter referred to as "JICA") held a series of discussions with General Company for Ports of Iraq (hereinafter referred to as "GCPI") and Ministry of Planning (hereinafter referred to as "MOP") of the Republic of Iraq to develop a detailed plan of the project on Master Plan Study for Port Sector in Iraq (hereinafter referred to as "the Project").

Both parties confirmed the results of the Main Points Discussed as described in the Appendix 1 and the Draft Record of Discussions Appendix 2 respectively.

### **Main Points Discussed**

- 5. GCPI requested that the meetings of JCC should be principally held in Basrah or Baghdad. The JICA mission took note of it.
- The JICA explained that if the meeting was held outside Iraq, meeting expenses and travel allowances would be covered by JICA. GCPI took note of it.

In response to the official request of the Government of the Republic of Iraq (hereinafter referred to as "GOI") to the Government of Japan (hereinafter referred to as "GOJ"), the Japan International Cooperation Agency (hereinafter referred to as "JICA") held a series of discussions with General Company for Ports of Iraq of the Republic of Iraq (hereinafter referred to as "GCPI") and relevant organizations to develop a detailed plan of the Master Plan Study for Port Sector in Iraq (hereinafter referred to as "the Project").

Both parties agreed the details of the Project and main points discussed as described in the Appendix 2-1 and the Appendix 2-2, respectively, and to request their respective governments to proceed with the necessary procedures for implementation of the Project.

Both parties also agreed that GCPI, the counterpart to JICA, will be responsible for the implementation of the Project in cooperation with JICA, coordinate with other relevant organizations and ensure that the self-reliant operation of the Project is sustained during and after the implementation period in order to contribute towards social and economic development of Iraq.

The Project will be implemented within the framework of the Note Verbal to be exchanged between GOJ and GOI.

#### PROJECT DESCRIPTION

#### I. BACKGROUND

Ministry of Transport (hereinafter referred to as "MOT") has made "Port Sector Development Plan" in accordance with the basic development policy of maritime transport described as a part of National Development Strategy;

- Restoration of Umm Qasr Port (hereinafter referred to as "UQP") and Khor Al Zubayr Port (hereinafter referred to as "KZP").
- Restoration of Maritime navigation safety through the removal of shipwrecks from access channels and port basin, and through capital and maintenance dredging.
- Development of a master plan to increase efficiency and optimize the institutional arrangement for ports and inland waterways.

Under the above policy, the Port Sector Rehabilitation Project is being implemented under Japanese ODA Loan in order to restore original capacity of the ports. Further, some rehabilitation works in other ports have been implemented or planned by the GOI financing.

Economic situation in Iraq is dramatically improved. It is recognized that such rehabilitation works and port development projects require an updated master plan. For example annual GDP growth rate was around 4% from 2006 to 2010, but it became about 9% in 2011, and it seems to keep above 8%. Those changes will highly affect the port sector.

In this context, it is essential to formulate a comprehensive port master plan, as well as the improvement and modernization in the port management & operation aspects, for sustainable economic development of Iraq.

# 9. Reports

- (2) 20 copies of Interim Report (1) at the time about 8 months after the commencement of the first work period in Iraq
- (3) 20 copies of Interim Report (2) at the time of 12 months after the commencement of the first work period in Iraq
- (4) 20 copies of Draft Final Report at the end of the last work period in Iraq
- (5) 30 copies of Final Report
- (6) within one (2) month after the receipt of the comments on the Draft Final Report

#### 10. Environmental and Social Considerations

GCPI agreed to abide by "JICA Guidelines for Environmental and Social Considerations" (April 2010) in order to ensure that appropriate considerations will be made for the environmental and social impacts of the Project.

#### III. UNDERTAKINGS OF GCPI AND GOI

- 1. GCPI and GOI will take necessary measures to:

- 2.GCPI and GOI will take necessary measures to:
  - (1) provide security-related information as well as measures to ensure the safety of members of the JICA missions;
  - (2) permit members of the JICA missions to enter, leave and sojourn in Iraq for the duration of their assignments therein and exempt them from foreign registration requirements and consular fees.
  - (3) exempt members of the JICA missions from taxes and any other charges on the equipment, machinery and other material necessary for the implementation of the Project:
  - (4) exempt members of the JICA missions from income tax and charges of any kind imposed on or in connection with any emoluments or allowances paid to them and/or remitted to them from abroad for their services in connection with the implementation of the Project; and
  - (5) meet taxes and any other charges on the equipment, machinery and other material, referred to in II-5 above, necessary for the implementation of the Project.
- 3.GCPI and GOI will bear claims, if any arises, against members of the JICA missions resulting from, occurring in the course of, or otherwise connected with, the discharge of their duties in the implementation of the Project, except when such claims arise from gross negligence or willful misconduct on the part of members of the JICA missions.

# IV. EVALUATION

JICA will conduct the following evaluations and surveys to mainly verify sustainability and impact of the Project and draw lessons. GCPI is required to provide necessary support for them.

- 1. Ex-post evaluation three (3) years after the project completion, in principle
- 2. Follow-up surveys on necessity basis

#### V. PROMOTION OF PUBLIC SUPPORT

For the purpose of promoting support for the Project, GCPI will take appropriate measures to make the Project widely known to the people of Iraq.

#### VI. MUTUAL CONSULTATION

JICA and GCPI will consult each other whenever any major issues arise in the course of Project implementation.


