UNCRPD(UN Convention on the Rights of Persons with Disabilities) has been ratified by 160 countries and regional integration organizations by January 2016. In many developing countries, the development of laws and systems based on the UNCRPD is an urgent task, and persons with disabilities (PWDs) are expected to play an active role in the process. This course aims to strengthen the capacity of leaders with disabilities in contributing to the UNCRPD implementation.

<b>【Outcome】</b> 1. To understand disability from a viewpoint of human rights and equality based on the UNCRPD. 2. To analyze the current situation of the implementation of the UNCRPD in respective countries and identify challenges to be addressed based on the perspective of “disability and development” . 3. To learn strategies and measures for promoting the participation of persons with disabilities in the society as well as the policy-making process in Japan. 4. To acquire skills for managing organizations. 5. To acquire skills for building networks at regional/national/international levels and for developing appropriate approaches for building such networks in their own countries. 6. To develop a final report on the implementation of the UNCRPD in their own countries.		<b>【Target Group】</b> PWDs who have been active as leaders in the above mentioned organizations for more than five years and are planning to work in the field of disability for more than three years.
