In many developing countries, various public works projects have troubles of its smooth project execution, because the projects have not gained understanding of the residents. This program aims at formulation of guideline for Public Involvement Process in public works projects with effort to involve participation of citizens from the planning stage of projects taking into account JICA Guidelines for Environmental and Social Considerations view points; in order to resolve troubles such as relocation, land acquisition and compensation, then contribute to smooth implementation of projects.
