In the Paris Agreement, entered into force November 2016, it requires all parties including developing countries put forward their best efforts to reduce total greenhouse gas emissions targeting in “nationally determined contributions” (NDC) and strengthen these efforts to implement the activities. In order to enhance capacity for development and implementation, and secure transparency for NDC in developing countries, this course aims to learn Japan’s experience in NDC, especially focusing on mitigation.
