in Pakistan?

Pakistan receives financial support from other countries. Its effect on economic growth has always been debated. This research is a secondary data based empirical analysis of the linkages between economic growth and external assistance coming in to Pakistan using Autoregeressive Distributed Lags (ARDL) econometric model with bound testing technique. It finds negative effect of foreign aid on economic growth in long run creating "dependency syndrome" effect, which restrict the economic growth and internal investment plans. Greater amount of loans is taken and then foreign aid is taken to reduce the loans resulting in negative implications for Pakistan economy in long run. However, it finds the positive effect of foreign aid on some economic accounts in short run. The study concluded that foreign aid is certainly persuading the financial growth in short run and negatively influencing the fiscal development of Pakistan and improvement in institutional quality and investments are key economic indicators to improve the per capita income growth of Pakistan in long run. It suggests that Pakistan should develop alternative sources of filling saving and investment gaps. Foreign assistance may be specified for sector specific projects and evaluated over the years to reallocate it for effective use.
