Statistical data in the second half of fiscal year 1999 are based on financial information of the International Financial Operations of JBIC.
- Statistical data concerning Overseas Economic Cooperation Operations are comprised of the statistical data of the Overseas Economic Cooperation Fund, Japan from fiscal year 1995 through the first half of fiscal year 1999. Statistical data in the second half of fiscal year 1999 are based on financial information of the Overseas Economic Cooperation Operations of JBIC.
- Classification of projects by country and region is based on the project-residing country for commitments made in fiscal 2000 and other JBIC-financed projects whose borrower changed in fiscal 2000. Projects before fiscal 2000 are classified based on the country where the borrower has legal residence.
