The Petroleum Corporation of Jamaica (PCJ) acting on behalf of the Government of Jamaica has received financing from the Inter-American Development Bank (IDB), Japan International Cooperation Agency (JICA) and European Union-Caribbean Investment Facility (EU-CIF) toward the cost of the Energy Management and Efficiency Programme (EMEP), and intends to apply part of the proceeds to payments under the contracting of works and services.
