

Sustainable forest management is promoted in Kenya towards the national forest cover target of 10%.



#### **Backgrounds of the Project**

It is expected that in the next 100 years, the average temperature in Eastern Africa could increase by 3°C as a result of climate change. Increasing forest cover is crucial in Kenya.

Devolution of sectral functions to the County Governments is set in the Constitution of Kenya, 2010.

The County Governments have the functions and the power to implement national government policy on forestry.

The Constitution of Kenya, 2010 and Vision 2030 require the country to work towards achieving a forest cover of at least 10% of the land area.

For more than 30 years, JICA has provided technical cooperation for KEFRI and KFS on promoting social forestry, and research and development on tree planting in ASALs including breeding for drought tolerant varieties.
