hawama, Chilenje, Chipata, Kanyana and Matero First Level Hospitals were recipients of shelves for their pharmacy departments from the JICA Cassiopeia Project who handed over 93 shelves to the 5 facilities. This activity was prompted from observations on the lack of adequate space for storing medicines and medical supplies needed by the hospitals as well as space for receiving medicines and supplies from Zambia **Medicines and Medical Sup**plies Agency (ZAMMSA) and dispersing them to the various departments.

Part of the third project output is ensuring that stock of management essential medical medicines and supplies is implemented target hospital to help each the pharmacy departments keep track of medicines and medical supply inventory.

Therefore, this activity will assist the hospitals in making it easier for pharmacists and pharmacy technologists to conduct medicine and medical supplies stock management. This will also have an impact on how pharmacies keep track of which medicines are most used at the facility (in order for them to plan

better), as well as keep track of medicines nearing expiration.

Another aspect increased shelving spaces is the impact on staff safety. medicine Previously, and medical supplies' boxes were stored in a haphazard manner risking the boxes falling on staff accessing medicines or medical supplies. Currently, pharmacy commodities are being stored in an organized and safe manner.

So far, all but Chilenje FLH have installed the shelves as the health facility is renovating a bigger pharmacy space for storing medical supplies freeing up the existing structure for medicines.

The increase in pharmacy shelving has been welcomed by pharmacists and all hospital administrations as the more organized and spacious working environment will have a direct impact on work output and how hospital clients are served. This will also impact how the various departments are served by the pharmacy department.

Mr. Kohei Shiota, Japanese expert on the JICA Cassiopeia Project who spear headed the technical support noted that for a long time, the pharmacies in the 5 FLHs which the project works in collaboration have had to make do with the space provided and he expressed his hope that the additional shelving space created will go a long way in alleviating some of the issues they faced in the past.

LUSAKA FIRST LEVEL HOSPITAL ADMINISTRATORS MEET TO FORMULATE TRAINING MANUAL ON BSC

he Lusaka Provincial Administration Office (LPAO) from February 5th to 13th, 2024 provided seven days of training on the 8th NDP Strategic Plan and Balanced Score Card (BSC) to provincial government administrators through the Cabinet Office Management Development Divion (MDD) team. Two senior managers from each targeted hospital under JICA Cassiopeia Project were invited to this training to enhance their understanding of BSC and management approaches in general. The workshop also focused on strategies to effective hospital management as well as building problem solving skills in administrators to take on challenges being faced in their day-to-day work environment.

After the successful province-wide training, senior hospital managers from 5 First Level Hospitals (FHLs) attended a workshop on March 5th at Lusaka Provincial Health Office (LPHO) to standardize a hospital training manual that could be adopted to align with each hospitals' vision as well as enhance management capacity in the hospitals. The workshop

output was a synthesized and adaptable training manual that each hospital can adopt and adapt it to their own needs while working from a guide on how to manage the hospitals was agreed upon.

Building on the workshop to align management training among the 5 FLHs in Lusaka, the Hospital Administrator and the Planner of Chipata First Level Hospital with assistance from LPHO, LPAO and the JICA Cassiopeia project led a two-day training session on the 18th and 19th of March to introduce to overall management (from the medical superintendent to all

heads of departments) strategies to hospital management and problem-solving skills based on the training conducted by MDD in February.

Various heads of departments took part in group work to discuss issues being faced at the hospital as a whole and in their respective departments. They also presented ways in which these issues can be mitigated or solved through the formation of a BSC adapted to departmental level.

The use of the BSC not only helps hospitals in how the

facilities are managed, but it also helps institutions align with the governments' goal to strengthen management in all government facilities.

Closing the training session, Dr. Thaddee Chibangu - Clinical Healthcare Specialist and acting Superintendent Chipata FLH - stated that he was impressed by the presentations and training conducted the various facilitators and acknowledged the need for capacity continued building which would only lead enhanced management capacity at the facility and ultimately

lead to better service delivery to hospital clients.

LPHO AND FLH STAFF PARTICIPATE IN ORIENTATION FOR KCCP IN JAPAN

participated in the Knowledge, Co-Creation Program
(KCCP) orientation conducted by JICA Cassiopeia Project staff at LPHO on 20th and
22nd of March 2024.

KCCPs are a form of technical cooperation that JICA carries out in Japan throughout the year. The programs are an important means of technical cooperation which supports human resource development. The first output of the JICA Cassiopeia Project is to strengthen hospital management capacity and improve governance systems within 5 FLHS. Therefore, some of the knowledge that Japanese ciety has accumulated, including its background in areas such as organizational know-how and social systems, can only be understood through first-hand experience.

Previous KCCP programs have focused mainly on building the management capacity of senior hospital. The first round of KCCP saw 5 Medical Superintendents and the Provincial Health Director, Clinical Care Specialist and Chief Environmental Officer from LPHO attend the training under the JICA Cassiopeia Project in 2022. In 2023, the nursing officer and hospital administrator from each of the 5 hospitals were accompanied by the Public Health Specialist and Chief Nursing Officer from LPHO.

This years' upcoming KCCP is continuing to bridge the gap between senior management to departmental heads of departments. Hence hospital planners and pharmacy heads from Chawama, Chilenje,

Chipata, Kanyama and Matero First Level Hospitals and some staff from LDHO and LPHO were introduced to what KCCP is and were oriented in what to expect when they travel to Japan for two weeks in June from the 12th to the 27th when they attend the capacity building program.

Another aspect of the 2024 KCCP is aligning departmental management styles and vision to that of the hospital. Furthermore, participants will be exposed to how hospital management is conducted in Japan with the express view that what is earned will be utilized in their day-to-day work after their training.

During the orientation, candidates were that they are expected to make a presentation on an action plan before their return to Zambia on what they will learn during their visit and how the program pertains to the facility they are coming from.

LUSAKA DISTRICT HEALTH OFFICE (LDHO) VISIT FLHS ON UPDATED MEDICAL EQUIPMENT WEEKLY REPORT

edical Equipment Officers (MEO) from Lusaka District Health Office (LDHO) accompanied by JICA Cassiopeia Project expert, Mr. Kohei Shiota on March 21st 2024 went on a visit of 3 First Level Hospitals to ascertain how Bio Medical Engineers (BME) and Medical Equipment Technologists (MET) were adapting to the revised medical equipment tracer list and weekly reporting as mandated by LDHO.

Mr. Friday Matafwali and Mr. Obed Samusiku together with Mr. Shiota held meetings with Mr. Joseph Kanyamale – BME from Chilenje FLH, Mr. Darius Mulenga – MET and Ms. Natasha Mwela (BME) from Chawama FLH and Mr. Francis Kapepe and Mr. Richard Mumba (BME) from Kanyama FLH.

In each meeting, LDHO focused on the correct reporting procedure departments must follow to alert METs and BMEs on equipment that are malfunctioning or not working at all. Also emphasized was the need for weekly rounds of the various departments to conduct maintenance works on all equipment as well as write and submit weekly reports to the team from LDHO.

The reports are utilized by the health facilities to keep track of what equipment is in working order, which requires minor repairs, those requiring major repairs, and those that cannot be fixed and should be listed for decommissioning. On the other hand, LDHO utilizes the weekly report to help identify the problems with the facilities medical equipment and advise them on the next steps to take especially with those requiring major repairs or those that need to be listed as obsolete.

The third output of the JICA Cassiopeia Project is to enhance stock management and of essential medicines and medical supplies and that appropriate management /maintenance of medical equipment is implemented at each target hospital.

Together with LDHO, Mr. Shiota encouraged the responsible parties to implement the medical equipment tracer list and adhere to the timelines put in place by LDHO.
