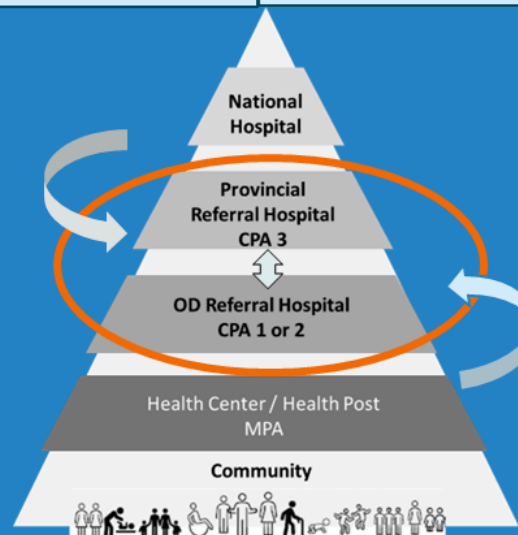

NCD CONTROL IN CAMBODIA

NCDs, including cardiovascular disease, diabetes and cancer, are leading causes of morbidity and mortality globally. In Cambodia, the burden of NCDs has been steadily increasing, posing significant challenges to the healthcare system.

The growing burden of NCDs across the country necessitates a coordinated approach in strengthening NCD program management and health service delivery across the care continuum, in line with the National Strategic Plan on NCD Prevention and Control 2022-2030.
