To collaborate with the regional efforts to reduce the food import bills by 25% and improve food security by 2025, JICA presented an innovative market-oriented extension approach to the CARICOM Region.



Also, in Belize, **Mr. Machida** and **Ms. Kawamoto**, Japanese Experts in the Agriculture Value Chain, conducted a workshop on the SHEP approach.

# **JICA Volunteer**

JICA's volunteer programs support activities by Japanese citizens who wish to cooperate in the economic and social development as well as the reconstruction of developing countries. Through these cooperation activities, participating volunteers can not only contribute to the development of partner countries but also gain valuable experience in terms of international goodwill, mutual understanding and an expansion in their international perspectives. 1,071 volunteers have been working with Caribbean people so far (as of June 2023).

The project consultation team for the project for **Strengthening Sustainable Use and Management of Coastal Fisheries Resources in the CARICOM countries** visited six (6) eastern Caribbean countries in February 2024. **Mr. Minoru Tamura**, Leader of the mission, Mr. Masaru Honda of the HQs, and **Mr. Hisashi Suzuki** of JICA DR review the progress, results, and challenges of pilot projects in the six countries through site visits and interviews with the relevant stakeholders and will analyze for reflection in future activities.

Based on the concept of the One Village One Product (**OVOP**) Movement, the **Ministry of Agriculture**, **Fisheries Food Security and Rural Development of Saint Lucia** is promoting education and human resource development for small-scale producers, building the capacity of those involved in the agricultural sector and improving the quality of life, through the establishment of local branded products by participating communities, to spread the concept of inclusive community development initiatives in which the population itself plays a leading role in community development. The Government hopes to promote the country's inclusive community development initiative, in which the residents themselves play a leading role in community development, as One Community One Product (OCOP, hereafter 'OCOP Saint Lucia'), Saint Lucia's version of OVOP.

### What is OVOP?

One Village One Product (OVOP) is a movement structured by the government but led by local residents voluntarily, based on the concept of developing one village by promoting at least one product where regional resources such as local agricultural products, specialty products, and tourism resources are accepted not just locally but worldwide.

# The Knowledge Co-Creation Program (KCCP)

JICA's Knowledge Co-Creation Programs are a form of technical cooperation that JICA carries out in Japan. Some of the knowledge that Japanese society has accumulated, including its background in areas such as organizational know-how and social systems, can only be understood through first-hand experience. The programs are an important means of technical cooperation which supports human resource development and resolving issues in developing countries.

#### My First Visit to the CARICOM Region!

My name is **Koichi Imura**, Latin America and the Caribbean Department of JICA HQs. I visited Guyana for one week in January 2024, as a member of a JICA's mission to formulate a new project for Guyana. We had a series of discussions with the officials of government agencies such as the Ministry of Finance, the Ministry of Foreign Affairs, and Guyana Water Inc. (GWI).

Guyana has made remarkable progress since the discovery of oil and gas reserves in 2015. I was impressed by the government's commitment towards the steady development of the country and its people. There are many ongoing constructions across the country. The streetscape in Georgetown was lovely with beautiful wooden buildings.

I was also impressed that Japan's cooperation in the past is still being utilized today. I met with several Ex-participants of JICA's training and counterparts of the past projects at the Ministry of Foreign Affairs and Guyana Water Inc. (GWI). I was pleased to see that they are bringing back the results of their training in Japan and applying what they have learned in their home countries. There are more than 200 Ex-participants of JICA's training in Guyana. In addition, I had the opportunity to visit a water treatment plant that was constructed with Japanese grant aid in 2008, and it was so well maintained and clean that it was hard to believe that more than 15 years had passed since its completion. We would like to build a new relationship based on Japan's cooperative assets to date.
