New Year's Message from Mr. Akiyama Shintaro, Director of Central America and the Caribbean Region

JICA wishes you all the best for the wonderful and successful year ahead!



The year 2024 marked the 60th anniversary of the establishment of diplomatic relations with Jamaica and Trinidad and Tobago, and various events were held to celebrate *Japan-CARICOM Friendship Year 2024*.

In February, Hon. Kamina Johnson Smith, Minister of Foreign Affairs and Foreign Trade of Jamaica visited Japan. In March, Dr. Carla Natalie Barnett, Secretary-General of the Caribbean Community (CARICOM) visited Japan and both met with JICA Executive Senior Vice President Miyazaki Katsura.

In August, JICA President Tanaka Akihiko visited Jamaica for the first time. Although it was immediately after the hurricane disaster, the team reviewed the results of Japan's cooperation on disaster prevention to date and exchanged opinions on future cooperation.

In November, **Senior Vice President Imoto Sachiko** became the first JICA board member to visit Guyana and visited the CARICOM Secretariat.

In addition, we had an opportunity to introduce JICA cooperation to the group of young diplomats participating in "Juntos", an invitation program implemented by the Ministry of Foreign Affairs of Japan, and exchanged views on cooperation in the field of disaster risk reduction.

In December, the **Japan-CARICOM Ministerial-Level Conference** was held in Tokyo, and Ms. Imoto took the opportunity to exchange views with representatives of the nine countries and the CARICOM Secretariat.

Furthermore, JICA held Caribbean photo exhibitions, Caribbean film screenings, and music events, making the Caribbean familiar to Japanese citizens.

In 2025, **the Osaka-Kansai Expo** will begin in April. Twelve countries from the Caribbean are expected to participate.

We will continue to work on strengthening our relationship with the Caribbean region and encourage more people in Japan to pay attention to the Caribbean region.

Collin Croal, Minister of Housing and Water, H.E. Yutaka Matsubara, Ambassador of the Embassy of Japan, Dr. Carla Barnet, Secretary-General of CARICOM, and Ms. Lorena Solorzano Salazar, IDB Country Representative in Guyana. Ms. Imoto had bilateral discussions with the agencies such as the Ministry of Finance.









Activities conducted by Mr. Naoki Matsumura, Regional Policy Advisor for Disaster Risk Reduction to CDEMA



In December 2024, the 13th Caribbean Conference on Comprehensive Disaster Management (**CDM 13**) was held from December 2-6, 2024 in St. Kitts and Nevis under the theme "Road to Resilience - Checkpoint 2024: Levelling Up for a Dynamic Future,". It is held every two years to discuss diverse issues including implementation of the Comprehensive Disaster Management Strategy (2014-2024). **The Honorable Dr. Terrance Michael Drew**, Prime Minister of St. Kitts & Nevis, Ministers from the Bahamas, Barbados, St. Kitts & Nevis, and Trinidad & Tobago, as well as the heads of disaster management organizations, around 400 people participated in the discussions on how to reduce disaster risk and improve disaster management capacity in the Caribbean region. I moderated a technical session on the Multi-Hazard Early Warning System connecting the Caribbean region and the Pacific region from a SIDS (Small Islands Developing States) perspective.

Apart from the above event, in November 2024, Japan's first Tourism Resilience Summit was held in **Sendai**, **Japan** where I presented a case study of JICA's Tourism Crisis Management Training Program for the **Caribbean region** implementing with the Global Tourism Resilience and Crisis Management Centre (GTRCMC) in Jamaica. In February 2025, the Second Tourism Crisis Management Training and Workshop will be held in Jamaica. The tourism sector is a very important sector in the Caribbean region, so we will continue to work on how to reduce the risk of disasters and how to promote build-back-better approach in the tourism industry.



In addition, I went to Colombia to discuss and seek a possibility of triangular cooperation in disaster risk reduction for the Caribbean region in November. As others are mentioned, I also participated in the Japan-CARICOM Friendship Year 2024 Event "Highlighting Past and Future Cooperation of Caribbean Water Sector" held in Guyana and made a presentation on JICA's cooperation on water and disaster risk reduction for the Caribbean region on behalf of CDEMA. We would like to continue working to improve the capacity of disaster risk reduction in the Caribbean region in 2025.

JICA Volunteer

JICA's volunteer programs support activities by Japanese citizens who wish to cooperate in the economic and social development as well as the reconstruction of developing countries. 1,105 volunteers have been working with CARICOM nationals so far (as of June 2024).






SHEP in the CARICOM Region

Smallholder Horticulture Empowerment and Promotion (SHEP) Approach was developed in Kenya through technical cooperation project by JICA. SHEP Approach is a market-oriented agricultural extension approach.







The Rural Agricultural Development Authority (RADA) conducted a SHEP training for agricultural and marketing extension officers from all parishes in Jamaica. The training was organized and implemented by Ms. Alicia Chambers, extension education specialist, with the full support of Mrs. Marina Young, CEO of RADA.

22 extension officers from all parishes in Jamaica completed the training and received the certification. Following the training, the participants are expected to introduce the SHEP approach to their colleagues and farmers within their respective parishes. Please visit

The Project for Strengthening Sustainable Use and Management of Coastal Fisheries Resource in the CARICOM Countries

The project has been promoting the consumption of Lionfish and Sea-moss. **Mr. Tetsuya Miyahara, a Japanese Expert** showcased the Lionfish Sushi/Tempura and Sea-moss Salad on various occasions such as at a local Japanese Restaurant, the Government office in **Saint Lucia**, and an event hosted by the Embassy of Japan. The Project also supported the Choiseul Secondary School to register with the U.S. Food and Drug Administration so that the school TVET program can teach comprehensive sea-moss business skills from production to export. Moreover, the Project supported the Choiseul Fishermen's Cooperative Society to reach the overseas market ensuring a better stable income, by registering them with the U.S. Food and Drug Administration.









The Caribbean Regional Fisheries Mechanism (CRFM) received a team from JICA Belize and shared information about the progress of the Sargassum project. JICA team expressed their gratitude to Mr. Hugh Milton, Executive Director, for his many years of cooperation with JICA and presented him with a final farewell address on his retirement. JICA Belize team also had dialogues with CCCCC and SIDS-DOCK Secretariat.
