## Message from the Chief Representative

Since the end of the political and military crisis in 2012, JICA has been working with Ivorian authorities on social reconstruction and stability in Côte d'Ivoire, with a focus on social inclusion, building police capacity and restoring trust between local administrative bodies and the population. Thanks to the social stability in recent years, Côte d'Ivoire is now recording high economic growth rates and is on the verge of significant development as the economic driving force in the sub-region.

In recent years, we have also been working to develop infrastructure and promote agriculture, fisheries, and other sectors to support Côte d'Ivoire's sustainable economic development. The total amount of JICA loans to Côte d'Ivoire in 2022 is 52.1 billion yen, the largest amount granted in sub-Saharan Africa. In addition, as a regional office since 2023, we will continue to support the stability and economic growth of Côte d'Ivoire.

A number of leading Japanese figures, including the Minister of Foreign Affairs, have visited Côte d'Ivoire since the beginning of 2024, as well as a number of Japanese companies. This is certainly a very important trend for strengthening bilateral relations between Japan and Côte d'Ivoire. JICA is promoting new initiatives such as digital transformation (DX) and regional cooperation and will continue to support the development of the region through Côte d'Ivoire as a regional hub and bridge between Japan and West Africa.






## Who are we?

The Japan International Cooperation Agency (JICA) is a public organism established in 1974 with the aim of bilateral cooperation in order to develop the society and economy of the beneficiary countries.

With a presence in some one hundred countries around the world, JICA carries out its activities in several fields through the following three schemes.

## Industrial development and job creation

Côte d'Ivoire accounts for 40% of total WAEMU GDP, but the proportion of low value-added products exceeds 80% of the value of goods exported, and the country imports around 4 million tons of food a year. Other challenges include a lack of human capital to promote economic diversification and industrial sophistication, and difficulty of access to finance, particularly for SMEs, which make up 96% of businesses in the country. The aim of the program is therefore to (I) Support (i) the primary sector, in particular the promo-

tion of agriculture and fisheries, (ii) the secondary sector, such as the processing of agricultural and fisheries products, and (iii) the tertiary sector which forms value chains; and (II) Create jobs by developing human capital through (i) the promotion of SMEs and improvement of their productivity, (ii) the improvement of access to finance and (iii) the strengthening of technical and vocational training.

## Sustainable development of infrastructure and corridors

Following the economic crises in the 1980s and 1990s, followed by the political and military crisis in the 2000s, combined with strong population growth, Côte d'Ivoire experienced low levels of investment in the creation and management of national and sub-regional rail, road, and electrical infrastructure, which deteriorated considerably. With the return to economic dynamism since 2012, Abidjan, the economic capital and hub of West Africa, is undergoing a rapid urbanization, causing urban problems such as environmental deteriora-

tion and traffic jams. JICA's infrastructure program has made it possible to (i) develop the Greater Abidjan Urban Master Plan (SDUGA), through which JICA is involved in the construction of priority transport infrastructure and the improvement of the urban environment, (ii) strengthen infrastructure between national cities, particularly the electrical network, and (iii) contribute to West African economic growth.

## Strengthening inclusive governance

After the end of the crisis in 2011, the Ivorian government promoted a reform of the security sector in order to establish a secure and peaceful society. JICA began supporting this initiative in 2013 through the development of human resources in the field of security and justice and the establishment of a social cohesion mechanism in Abidjan. The objective of the program has now been

reformulated as follows: Strengthen inclusive governance through (i) the improvement of access to the local police and judicial system; (ii) the improvement of inclusive and equitable social services by strengthening local administration (iii) and the strengthening of resilience against extremists in the northern Sahel.

The project aims to improve the quality of relations between the public and the police by strengthening the institutional and organizational framework of community policing and providing sufficient and qualified human resources.

## Promoting universal health coverage as well as maternal and child health

The health sector was hard hit by the military and political crisis, from 2002 to 2011. This resulted in low investment in the sector, with health indicators rising as a result. Due to this situation, in 2017, JICA, in agreement with the Ivorian authorities, set up a program to promote Universal Health Coverage that focuses on women, children and the needy. The objective of the program is to

provide support to reinforce basic social services in order to achieve Universal Health Coverage by (i) strengthening the healthcare system and promoting its use in health centers, general hospitals and university hospitals, and (ii) supporting institutional development and its implementation to promote the medical security system for poor households, including mothers and children.

With a capacity of around 150 beds, the hospital comprises a number of units, including a pediatric and gynecological Emergency Room, an Operating Unit (5 operating rooms), a Maternity Ward (10 delivery rooms), an Intensive Care unit, a Neonatal unit, a gynecological and pediatric Inpatient Unit, a Laboratory, a Radiology Unit, Sterilization facilities, etc. The quality of the infrastructure and equipment (Ultrasound scanners, Operating tables, Mobile radiology, Scialytics, incubators, etc.) of the Gynecology, Obstetrics, and Pediatrics' Unit of the Cocody Teaching Hospital, makes it one of the most modern specialized hospitals in the sub-region.

## Training, Former Trainees Network and JICA Chair

Sending Ivorians to Japan as part of the capacity-building program began in the 1980s, initially through the Japanese Embassy and then through JICA. It is one of JICA's flagship program and the longest standing in the framework of cooperation with Côte d'Ivoire. It has been renewed every year without interruption, even during the socio-political crisis that CI has experienced. To date, more than 1,500 participants have been trained. In addition to theoretical training, these participants take part in immersion visits and exchange

views with organizations in relevant sectors in Japan. They share their experiences with trainees from other countries. There is also a framework for sharing knowledge on the history of Japanese development, called JICA Chair, which enables exchanges between Ivorian and Japanese intellectuals. The capacity-building program, which is the basis of the solid relations between these two countries, facilitates the implementation of development activities.



- 4 Human resources from beneficiary countries who play a leading role in nationbuilding are accepted for 'internships' in Japan or a third country. These internships consist in taking part in conferences, field visits, practical training, presentations and exchanges of opinions based on the concept of 'co-creation', as learning together as equal partners, thus creating new added value. In order to contribute to solving problems faced by beneficiary countries thanks to Japan's knowledge and experience, we cover a wide range of fields, from hospital management know-how and local self-government systems to cutting-edge science and technology.

- 1 Association des Anciens Stagiaires Ivoiriens de la JICA (ASI-JICA), Kakehashi Africa
- 3 ASI-JICA was founded in 1989 and currently has over 400 members. Its activities to date include strengthening former trainees networks and organizing events to present Japanese culture in Côte d'Ivoire. In addition, between 2013 and 2019, more than 20 trainees from Côte d'Ivoire have benefited from the ABE Initiative and they created in 2020, the Association of former trainees of ABE Initiative (Kakehashi Africa). The aim is not only to strengthen former trainees networks and encourage new candidates, but also to act as a bridge between Japan and Côte d'Ivoire, for example by promoting Côte d'Ivoire to Japanese companies and providing information to Japanese companies which are interested in Côte d'Ivoire.

Lecturers will be sent from Japan to universities in the beneficiary countries to give short intensive courses. In February 2024, a conference was organized in collaboration between Japan Corner and FHB University on the theme 'Advancing Industrialization and Improving Labor Productivity: A Path for the Development of the Ivorian Economy'.

### 2 Long-term training

- 4 Long-term trainees coming to Japan are eligible for scholarships for postgraduate studies such as master's degrees and doctorates. These programs enable them to acquire comprehensive and advanced skills and knowledge in order to contribute to the development of their home country. Depending on the program, students can receive practical training (internship) in a Japanese company during or after their studies, or after graduation. ### Column : Japan Corner

Japan Corner is located in the Félix Houphouët – Boigny University, Abidjan-Cocody. Its purpose is to promote the study of the Japanese language and research on Japan in Côte d'Ivoire and West Africa. 


