I am very pleased with PAREDD Project so with its various support to my village such as funds,


equipment, technical knowledge and skills for implementing three types of activities which include:

Project Description for REDD+ is ready for Peer Review

This project was initiated to reduce and control deforestation caused by the expansion of pioneer shifting cultivation among natural and secondary forest and the shortening of fallow periods, based on participatory land and forest management in Houaykhing Village Cluster (HK-VC), Phonsay District, Luang Prabang Province, located in the northern part of Lao PDR

In the targeted site, to reduce pressures on forest resources and reduce deforestation, the project applied the PAREDD Approach which consists of three stages, Planning Stage, Implementation Stage and Monitoring Stage.

This Project Description (PD) was prepared by through a close collaboration involving the Japan International Cooperation Agency (JICA), the Department of Forestry (DOF) under the Ministry of Agriculture and Forestry, the Luang Prabang Provincial Agriculture and Forestry Office (PAFO) and Phonsay District Agriculture and Forestry Office (DAFO).

On 20th May, workshop for introducing the Project Description (PD) to concerned departments of Lao Government was conducted and collected comments on it. The PAREDD is now preparing third party peer review to confirm a feasibility of the Project Description.

The initiative of Longlath village, Phonxay district on land use zoning

After spending 2-3 weeks during April 2014, Phonxay District Agriculture and Forestry Office (DAFO) in collaboration with other line offices in the district and villagers were able to satisfactorily complete land use zoning in Longlath village, Huaykhing village cluster, in an unquestionable way. Longlath village was first registered as one of the total six target villages of PAREDD project in 2010. Not long after that, following the government decision, Longlath was ordered to move to another better location but the re-settlement failed due to some inexplicable reason. Consequently, in 2013 the government agreed for Longlath village to be revived. Initiated by Phonxay DAFO, and with support from PAREDD project, land use zoning was successfully conducted in Longlath village with a view to not only mapping out the whole land use zones under Huaykhing village cluster in a complete way but for Longlath to know its clear boundary and land use zones in preparation for future development as well.

The achievement this time has shown that DAFO staff have quite good experiences to do this kind of job (land use planning) well which it is hoped that it can be expanded to a wider area in the future by themselves.

In addition, LFMC members were also encouraged and mobilized to be more active in their routine work in order to be able to continue to give support to all of the activities, particularly after the project end.
