DSD/JICA Project on Disability

Department of Social Development (DSD) / Japan International Cooperation Agency (JICA) Project for the Promotion of Empowerment of Persons with Disabilities and Disability Mainstreaming

Project activity is included in the 5 year activity plan of National DSD!

The project organised the 5th Joint Coordinating Committee (JCC) meeting in March 2019. The meeting was facilitated by Mr Peter Netshipale, Deputy Director-General (DDG), community development of the Department of Social Development (DSD) and 30 people including officials of national and 4 project target provincial DSD. Collins Chabane municipality, ward councilor. representatives with disabilities from the project sites, Embassy of Japan, JICA South Africa office, etc. attended. The main objectives of the meeting were to 1) share the progress on Disability Empowerment and Mainstreaming (DEM) of national and 4 provincial DSD (Limpopo, Free State, Eastern Cape and KwaZulu-Natal), 2) share the 1st edition of the DEM Guidelines and 3) approve the activity plan of FY2019/20.

First of all, national DSD presented the progress that Community-Based Inclusive Development (CBID) was included in the Annual Performance Plan (APP) which is the 5 year (2019 - 2023) activity plan of the national DSD. CBID is the activity which empowered with disabilities. families, persons community stakeholders working together inclusive to create an community that the project has been dealing with. Included in the APP means the DSD national secured part of the budget to conduct project activities.

Next, the officials of DSD Eastern Cape and KwaZulu-Natal announced that OR Tambo district and iLembe district were selected as project sites to commence the project activities from April 2019 with the ownership of DSD. Two provinces will start the activities in earnest such as stakeholders' meeting and DEM introductory workshop, etc.

Then, the completion of the 1st edition of the DEM Guidelines which compile the lessons learnt of the project activities in Limpopo and Free province was shared. State The Guidelines will be updated to the 2nd edition in February 2020 by reflecting the outcomes of the activities in Eastern Cape and KwaZulu-Natal province. Lastly, participants approved the activity plan 2019/20, including activities in 4 project sites and update of the DEM Guidelines.

Kick-off meeting was held in Eastern Cape!

The project had the meetings with officials of Eastern Cape DSD and stakeholders on 15th and 16th May and confirmed the project site as Nyandeni municipality and approved the activity plan.
