- 1. The Sixth Joint Coordination Committee was convened on 22 July 2021 scheduled between 13:30 and 16:00 via Microsoft Team online conference platform, and opened by the Assistant Secretary-General of the National Institute for Emergency Medicine (NIEM), Dr. Chaiyaporn Suchatsoonthorn, on behalf of the ARCH Project Director, Flt.Lt. Atchariya Pangma, the Secretary-General of the NIEM, who cannot attend the meeting due to urgent appointment. Dr. Chaiyaporn Suchatsoonthorn greeted the participants and informed the meeting of the objective of this JCC meeting which is to seek endorsement of the Detailed Design Report and the Record of Discussion of ARCH Project Phase II.
- 2. The Chief Representative of JICA Thailand Office, Mr. MORITA Takahiro, delivered an opening remark and extend his appreciation for all the people concerned for their great contribution to the Project from the beginning of the project until today. Japan intends to expand diplomatic missions to secure human security in the region, promoting peace stability and cooperation. Japan is looking forward to cooperate with one another in the future.
- 3. The 30 committee members and participants had their chances to introduce themselves to the meeting.
- 4. Minutes of the Fifth Joint Coordination Committee was reviewed by Ms. Sansana Limpaporn. She reviewed the procedures in which the minutes will be circulated and approved by the participants. The meeting acknowledged the minutes of the Fifth Joint Coordination Committee.
- 5. Progress Report of the ARCH Project was delivered by Mr.Surachai Silawan, Project Director, indicating that there are eight activities in the Re-Extension phase; including the drafting of the work plan for POA on Disaster Health Management, Regional Collaboration Drill, Information sheet format for lesson learned from disaster response and the actual case, endorsing the regional collaboration tools by ASEAN (with feedback of minimal revisions), recommendation for ASEAN standards or methods on some necessary issues for deployment of AMS-EMT, study reports on curriculum development on disaster health management in AMS, academic international seminar and developing the standard curriculum on disaster health management. During COVID-19, the project has conducted several online meetings and activities.

#### Plan of the Activities in the Remaining Period of the ARCH Project

- 5. Progress of the development of the two ASEAN Standard Curriculum on Disaster Health Management were presented by Dr.Phumin Silapunt. Dr.Phumin indicated that these are the first curriculum and the first time ASEAN develops this standard educational program together. It was mentioned that the activities started back during the PWG2 meeting in Bali 2019 followed by three sub-working group meetings participated by two members from each member state. There are two standard curriculums; including the Basic Disaster Health Management Course with 15 modules in which each member state has participated in drafting up the modules. The 3<sup>rd</sup> SWG has agreed with the core contents of each module with some feedbacks and comments. The second course is the Coordination Course which is the In-country course in order to ensure that the affected AMS will be well-prepared to coordinate with the incoming EMTs during disasters. Now, the project is seeking the resource persons for these two courses.
- 6. The presentation by Mr.Ikeda was combined three topics for the publication of ARCH Articles in an International Journal, ASEAN Academic Conference and Project Working Groups Meetings.. First, Mr. IKEDA made overviewed on the concept that ARCH Project has produced a lot of knowledge but is not known to experts and academicians outside of the ASEAN region and Japan. Therefore, the project decided to add the additional activity to create publications on ARCH-related activities in an influential international academic journal on DHM which is the Pre-hospital and Disaster Medicine (PDM) Journal.

ARCH Project related manuscripts will be published as a supplementary issue of the PDM. The project has invited the Thai task force and core members of RCD host countries as well as JAC members and JICA advisors to write manuscripts for the academic articles of the supplementary issue. To prepare, the project sought for professional advises, and created Advisory Working Group consisting of the Japanese academicians on DM with.Dr.Phumin and Dr.Prasit The manuscripts were expected to be submitted around end of August.

Secondly, the ASEAN Academic Conference was expected to be convened between 23-25 November 2021 in Thailand and virtually depending on the COVID-19 situation in Thailand. The conference will be convened with the theme of "How can ASEAN realize One ASEAN, One Response in the field of disaster health management?". The conference will be a kick-off for the establishment of the ASEAN Academic Network and to share the articles published in the PDM journal. The project would like to invite the candidate members of the ASEAN Academic Network to participate, invite representatives from World Health Organization, presenters of the articles from the AMS.

Third, the Project Working Groups Meetings in the remaining period will be planned to be organized in the late August for PWG1 and PWG2 virtually, and organize joint meetings of both PWGs in late November 2021, face-to-face, back-to-back with the Academic Conference.

Dr.Anupong is concerned about the plan for conducting the ASEAN Academic Conference during the pandemic, suggesting to use webinar instead. If we need to conduct once in every two years, using webinar is a good start. Dr.Phumin responded that the online meeting has already been considered as a back-up plan. If the government of Thailand opened the country and accepted the foreigners, the conference may be conducted face-to-face. The project has to monitor for some time to make a decision. The project will discuss again during the PWGs Meeting. Dr.Anupong concerns that the time the project has left to decide and plan for the conference is less and less. If the project still confirms to do so, the project needs to make a good plan.

#### Preparation of ARCH Project Phase II

9. The representative of JICA, Mr. ASHIDA, summarized the Basic Principles for Technical Cooperation. When JICA begins the project, detailed planning survey must be conducted to make common understanding on JICA Technical Cooperation Project. Given the current situation, the detailed planning survey for ARCH 2 shall be conducted remotely through online meetings and the developing of Detailed Design Report. This detailed planning survey for the ARCH 2 is expected to be conducted during June and July 2021. The basic principles is composed of eleven components/items. As for the Implementation Structures, the Joint Coordination Committee (JCC) must be organized for JICA technical cooperation projects. Other important components are the Undertaking of the Counterparts (i.e., Section 4.1 Privilege /Section 4.2 Convenience for the members/ Section 4.3 Services), Reporting and the Monitoring and Evaluation. The schedule for the commencement of ARCH 2 was explained. The approval procedure for signing of Record of Discussions (R/D) of the project will take three months from the Thai side; therefore, it will start in August.

Mr.Wattanawit from TICA asked the question on the "Undertaking of the Counterparts" if the Counterparts for this project are NIEM and MOPH. Mr.ASHIDA confirmed his comments. Mr. Wattanawit thinks that some responsibilities belongs to TICA and not NIEM or MOPH, so the overall sections could be broadened to other related agencies. As such, the wording ".....the Counterparts" should be changed to ".....Thai side". Mr.ASHIDA claimed that this is put to remind of the technical

cooperation. Mr.IKEDA responded that the document will not be put as the direct part of the RD but it is just a reference document of the RD that should be applied to all JICA projects all over the world.

10. The Detailed Design Report (DDR) was presented by Mr. IKEDA. DDR is a product to the detailed planning survey. Since last month, the team is trying to make DDR in consultation with the Thai side about the designing of the new project. The draft DDR was circulated to all the main players of the Thai side and submitted to the project Director. On 29 June, the project director acknowledged it. The DDR outlines the project framework indicating the project period, project purpose, which aligns with the goal of the Plan of Action to Implement the ASEAN Leaders' Declaration on Disaster Health Management, the expected outputs that reflected three priority areas of the POA, verifiable indicators of the overall goals and purpose (12 targets of the regional level targets of POA, partially support for the national targets). Major events are outlines in the DDR indicating the frequency of conducting each activity in each year. The DDR also outlines the inputs from both Thai side and Japanese side and the implementation structure. During August, JICA will issue a facilitation letter for signing of the R/D to TICA. During August to October, Thai side will perform their procedures of the signing and by the second week of November, the R/D is expected to be designed. The PDM or Project Design Matrix will be attached as the Annex of DDR and also the Plan of Operation (PO) as a tentative implementation plan of the project.

Draft R/D is also attached in this DDR. Three parties will sign in this R/D. The R/D will state the purpose, background of R/D, terms of conducts for the cooperation under this project. The main points discussed will be put in Annex 1 stating the administration of the project, the implementation structures and Undertaking of the Counterparts. Japanese side plans to dispatch one more JICA expert and hire one more project assistant to the project; therefore, a bigger office need for the JICA expanded project team.

Dr. Anupong made a comment on appreciating JICA for their continuous support to the project.

Mr.Wattanawit appreciated all agencies' effort. TICA has supported the ARCH Project Phase II and facilitated for the process of approving, signing, and implementation of the Project. He asks for the progress of the drafting of the R/D since there is less time. TICA is not the delivery of the R/D from Japanese side to Thai side, but TICA would like to see the full text of draft R/D internally if there is any comments so that the R/D can be revised before JICA officially send R/D to TICA for Thai counterpart agencies for confirmation of the R/D contents. In this regard, he suggests that, to expedite the whole process before signing, all concerned agencies should internally review the full contents of R/D and provide the feedback until it leads to final version so that JICA can kick-off the final R/D from Japanese side to Thai side.

Dr.Suriya had raised two points. First, the new JCC under the ARCH Project II. MOPH as the co-partner, he mentioned it will be better to have co-chair of the JCC from MOPH other than the Secretary-General of NIEM. Secondly, RCCDHM is a mechanism that have already established, thus ARCH project has to work with and under its guidance. It needs a clear protocol to identify role and function of each body. For instance, when ASEAN Academic Network is planned for its first meeting by ARCH in November 2021, as the activity has been endorsed in POA, then it is RCCDHM who take its responsibility to consider the Network Establishment Framework including its steering body and composition, its role and function, network membership, the secretariat, etc. Therefore, ARCH should deliver a concept note describing Academic Network and submit to RCCDHM and Health Cluster 2/ASEAN SOMHD for consideration at least 6 months in advance.

Dr.Jiroj made his proposal. He thinks that the project should cover biohazard element to the project in addition to the natural disasters, and raised the question whether the project can set the working group to work in the biohazard or pandemic issue. The project can link the evidence-based information between countries, conduct the drill on pandemic, etc. He asked whether phase II incorporate pandemic into the project. Dr.Anupong responded that since the ASEAN Summit in 2019, ASEAN agreed to establish the ASEAN Center for Public Health Emergency and Emerging Diseases, they already have the feasibility study to set up this center by McKinsey Institute. This goes to the AHMM meeting. Dr.Chaiyaporn responded on behalf of NIEM that the organization may not have expertise on this area; however, it is ready to support the Ministry of Public Health if it leads.

Dr.Saowapak responded on the issue of joint assistance among countries in the region. In the past, Thailand has deployed the joint investigation team to other countries during various epidemics and disasters. However, in the case of COVID-19, the Emergency Decree limited travel between countries. To reduce this gap, Thailand provides technical support including clips of laboratory protocols, case management and quarantine management to distribute other countries. For face-to-face assistance, Thailand must seek approval from the Centre for COVID-19 Situation Administration (CCSA) to invite the team to come to Thailand or send to other countries. When the situation improves, DDC will inquire if there is a possibility.

Mr.IKEDA responded on JCC. JICA welcomed the involvement of MOPH and it is a very good idea for MOPH will take responsibility as Co-chair. About relation between RCC-DHM and ARCH Project, RCC-DHM will cover larger responsibility related to the POA. ARCH Project would like to work closely with the Secretariat of the RCC-DHM. ARCH Project can give comments and advices to the RCC-DHM. To respond to Dr.Jiroj, ARCH 1 already initiated some activities related to the pandemic, and can be continued to ARCH 2 and it is necessary to discuss how ARCH2 can work for activities on the pandemic and public health emergencies in collaboration with other ASEAN initiatives such as ASEAN Center for Public Health Emergency and Emerging Diseases

The chairman declared the endorsement of the JCC meeting on the Detailed Design Report of the Project for Strengthening the ASEAN Regional Capacity on Disaster Health Management (ARCH Project) Phase II, Draft Record of Discussions (R/D), Project Design Matrix (PDM), and Plan of Operation (PO) of the Project for Strengthening the ASEAN Regional Capacity on Disaster Health Management (ARCH Project) Phase II.

#### SUMMARY OF AGREEMENTS AND WAYS FORWARD

#### UPDATES FROM ASEAN SECRETARIAT

 Noted the decisions relevant to the ARCH Project and Disaster Health Management, which emanated from recent ASEAN Meetings, namely the: 16th JTF on HADR, 38th/39th ASEAN Summits and Related Summits, 16th ASEAN SOMHD and Related Meetings, and the ASEAN Health Cluster 2 Planning Meeting.

#### OVERALL PROGRESS OF THE ARCH PROJECT EXTENSION PHASE

- Noted the overall progress of the ARCH Project Extension Phase across the five project outputs, including the following:
  - Organization of the Regional Coordination Committee on DHM (RCC-DHM);
  - Adoption and implementation of the POA to operationalise the ALD on DHM;
  - Development of the ASEAN EMT SOP and its integration with ASEAN SASOP;
  - On-going establishment of the ASEAN Institute on Disaster Health Management (AIDHM) and ASEAN Academic Network on Disaster Health Management (AANDHM);
  - Conduct of Regional Collaboration Drills, and development of a Preparation Handbook;
  - Conduct of the inaugural ASEAN Academic Conference;
  - Development of the ASEAN Collective Measures (ACM);
  - Development of standard curricula for Basic DHM Course and In-country Coordination Course; and,
  - Publication of ARCH Project Handbook, supplementary edition of ARCH articles in WADEM's Pre-hospital and Disaster Medicine journal, and the COVID-19 Case Study.
- Agreed on the need for an organized knowledge management system, including information storage

#### PROGRESS ON STANDARD CURRICULUM DEVELOPMENT

- Noted the progress on the development of two standard curricula, the Basic DHM Course (B Course) and In-Country Coordination Course (C Course);
- On the B Course, <u>further noted</u> the course objectives, plan of action, schedule and details of the proposed conduct of the workshop, and ways forward;
- For the C Course, <u>further noted</u> the course objectives, progress of curriculum development where currently in the implementation plan design after completion of course framework and formulation, and future planning
- Noted the planned next activities, including preparation of a face-to-face mock-up workshop in late 2022.
- 1 Summary of Agreements & Ways Forward, Second Online Joint PWG Conference ARCH Project 14 December 2021 via video conference

## RESULTS OF THE PREPARATORY MEETING FOR THE ASEAN ACADEMIC NETWORK ON DISASTER HEALTH MANAGEMENT (AANDHM), AND THE ASEAN ACADEMIC CONFERENCE

- Noted the conduct and outputs of the Preparatory Meeting for the AANDHM. <u>Further noted</u> the previous circulation of revised TOR of Steering Committee which was amended from National Focal Point Meeting for review and/ or endorsement with the deadline by 31 Dec 2021, including a consideration of a proposed name, 'Steering Committee'. The TOR shall subsequently be proposed to RCCDHM in mid-Jan 2022;
- Noted the conduct of the inaugural ASEAN Academic Conference on DHM, and the key points from the four sessions and one panel discussion;
- Noted that three ASEAN Member States have submitted nominations for their
  AANDHM NFP Institute and at the same time kindly requested the rest of AMS to
  complete the identification/nomination of their NFP Institute, and to share the
  information to the RCCDHM Secretariat, copy furnished the ASEAN Secretariat
  and the ARCH Project Team with the deadline by the end of Jan 2022. The list of
  NFP shall subsequently be submitted to RCCDHM for their advanced review prior to
  the RCCDHM Meeting in Feb/ March 2022;
- Noted the AIDHM as the proposed secretariat of AANDHM and which role is assumed by the RCC-DHM Secretariat in the interim while the Institute is still being set-up;

## REPORT OF THE ONLINE PROJECT WORKING GROUP 1 CONFERENCE PROJECT FOR STRENGTHENING THE ASEAN REGIONAL CAPACITY ON DISASTER HEALTH MANAGEMENT (ARCH PROJECT)

23 MARCH 2021, 9:00-11:00AM BANGKOK TIME

#### INTRODUCTION

- 1. The Meeting was chaired by Thailand as Lead Country of the ARCH Project and attended by designated contact points for Project Working Group (PWG) 1 from Brunei Darussalam, Cambodia, Indonesia, Lao PDR, Malaysia, Philippines, Singapore, Thailand, and Viet Nam, as well as representatives from the ARCH Project Team, Japanese Advisory Committee, Japan International Cooperation Agency (JICA), ASEAN Coordinating Centre for Humanitarian Assistance on disaster management (AHA Centre), and ASEAN Secretariat. The List of Participants appears in Annex 1.
- The Meeting was convened to continue the implementation of priorities within the ARCH Project Extension Phase specifically under the purview of PWG 1 in consideration of travel restrictions resulting from the COVID-19 pandemic. The agenda appears as <u>Annex 2</u>.

#### **OPENING REMARK**

3. Dr. Jirot Sindhvananda, Senior Adviser to Chulabhorn International College of Medicine, Thammasat University, and as Chair of the Meeting, delivered opening remarks. He welcomed the participants and highlighted their contributions to initiatives under the PWG 1 of ARCH Project to advance disaster health management, namely the Standard Operating Procedures for the Coordination of Emergency Medical Teams in ASEAN (ASEAN EMT SOP) the and ASEAN Collective Measures for ASEAN Member States International-EMT (ACM) and which progress would be discussed. He also underlined the importance to discuss the implementation of key activities of the ARCH Re-Extension Phase and the preparations for ARCH Project Phase 2. Dr. Sindhvananda also expressed his appreciation to the partners for their support and looked forward for a productive and fruitful discussion.

#### UPDATES FROM THE ASEAN SECRETARIAT

- 4. The Meeting noted the updates from the ASEAN Secretariat on the sustained and expanded ASEAN Health Sector's response to the COVID-19 pandemic including initiatives for strengthening regional public health emergency preparedness. The update focused on (i) the establishment of the ASEAN Centre for Public Health Emergencies and Emerging Diseases (ACPHEED), (ii) the development of ASEAN Public Health Emergency Coordination System (APHECS), (iv) the ASEAN-WHO-EU project on Enhancing regional coordination in response to COVID-19, and (v) the Strengthening ASEAN's Capacities on Crisis and Health-Related Communication supported by GIZ. The ASEAN Secretariat also briefed the Meeting on commitments of support from Dialogue Partners that were announced at the 36th/37th ASEAN Summit and Related Meetings in November 2020; as well as the upcoming sectoral events that are relevant to the ARCH Project. The presentation appears as Annex 3.

## UPDATES ON THE FINALIZATION OF EMT SOP AND INTEGRATION OF EMT SOP INTO ASEAN SASOP

- 5. The Meeting noted the updates from the ARCH Project Team on the progress of consultations on the revisions of the draft ASEAN EMT SOP resulting from the (i) table-top exercise involving representatives from health and disaster management sectors of ASEAN Member States organised by AHA Centre and ARCH Project and supported by the ASEAN Secretariat as part of the process of integration of the ASEAN EMT SOP into the ASEAN Standard Operating Procedure for Regional Standby Arrangements and Coordination of Joint Disaster Relief and Emergency Response Operations (SASOP), (ii) further inputs from the ASEAN Committee on Disaster Management (ACDM) Working Group on Preparedness, Response and Recovery (ACDM WG PPR) through the AHA Centre, and (iii) recommendations from the Sub-Working Group on ASEAN Collective Measures for ASEAN I-EMT (SWG-ACM). The Meeting also noted the summary of revisions, and the recent endorsement of the revisions by the Regional Coordination Committee on Disaster Health Management (RCC-DHM). The presentation appears as Annex 4.
- 6. Moving forward, the Meeting further noted that the revised ASEAN EMT SOP will be elevated to the ASEAN Health Cluster 2 on Responding to All Hazards and Emerging Threats for further review and/or endorsement, and subsequently transmitted to ACDM WG on PRR for final testing through the ASEAN Regional Disaster Emergency Response Simulation Exercise (ARDEX) scheduled in March 2022. Relatedly, the AHA Centre also provided updates on ARDEX where the ASEAN EMT SOP has been agreed to be tested, and that the exercise is likely to be held through online platform consisting of table-top and functional exercises. The AHA Centre representation also suggested that the ASEAN EMT SOP should be general, as much as possible, as it will be integrated to the ASEAN SASOP.

#### UPDATES ON THE ASEAN COLLECTIVE MEASURES FOR AMS I-EMT

- 7. The ARCH Project Team updated the Meeting on the progress of SWG-ACM's work which, based on the analyses of the regional context, and capacity gaps or challenges, have put forward recommendations to address operational challenges in the deployment of EMT that are fulfill WHO EMT standards. These recommendations include the development of (i) Database of Receiving Country for I-EMT deployment, (ii) Guidance on Medical Malpractice, (iii) and Guidance on Waste Management. The Meeting also noted the proposed ways forward/timeline in the finalization of the recommendations. The presentation appears as Annex 5.
- 8. The Meeting exchanged views and further noted the following:
  - The database is still at its initial stage. It is envisaged to be a living document owned
    by each AMS that will be completed and updated at any time the AMS, through their
    focal points deem it necessary. As such, each AMS is encouraged to organize Incountry Course for the Coordination of EMT (which is currently finalized by PWG 2),
    which is also an opportunity to update their national database.
  - The information requested in the database may be confidential or difficult to collect as shared by some PWG 1 members.

- AMS may provide or update information on the database to the ARCH Project Team
  as the need arises using the latest version of the form;
- These issues will be further studied as part of the ARCH Project Phase 2. The SWG-ACM may also wish to consider looking into the mechanism of data collection in updating the list of modules for deployable assets, among others, by the AHA Centre as reference.
- The Meeting also agreed to review and provide inputs on the SWG-ACM interim report and recommendations for further consideration at the next SWG-ACM meeting planned in July 2021.

## PLANNED ACTIVITIES FOR THE ARCH RE-EXTENSION PHASE, AND UPDATES ON THE PREPARATION OF ARCH 2

- 10. The Meeting noted the updates from the ARCH Project Team on the implementation of endorsed activities during the re-extension phase of the ARCH Project and the preparation of ARCH Project Phase 2. The Meeting further noted the proposed framework, outputs and key activities of ARCH Project Phase 2 which will be implemented between 2022-2025 and which supports the implementation of the Plan of Action to operationalize the ASEAN Leaders Declaration on Disaster Health Management (POA/ALD on DHM) 2019-2025, including the completed or on-going consultations for review and endorsement at AHC 2, Senior Officials Meeting on Health Development (SOMHD), and ASEAN Committee of Permanent Representative (CPR) levels as part of the ASEAN project appraisal and project approval process. The presentation appears as Annex 6.
- 11. Furthermore, the Meeting agreed to consider the enhancement of mutual learning during the ARCH Project Phase 2, including the facilitation of AMS with WHO-verified EMT as mentors to other AMS which undergo EMT accreditation processes. The Meeting also encouraged and enjoined the continued participation and support of all PWG 1 members and contact points of AMS in the finalization of consultations of project proposal and implementation of ARCH Project Phase 2.
- 12. Subsequently the ARCH Project Team also provided brief update related to the documentation and sharing of good practices on COVID-19 response with potential upcoming activity is an experience sharing by Singapore. The Meeting also agreed on the dissemination of good practice on COVID-19 among AMS.

#### INTRODUCTION

- 1. Chaired by Thailand as Lead Country of the ARCH Project, the Meeting was attended by Project Working Group (PWG) 1 Members from Brunei Darussalam, Cambodia, Indonesia, Lao PDR, Malaysia, Philippines, Singapore, Thailand, and Viet Nam, as well as representatives from the ARCH Project Team, Japanese Advisory Committee, Japan International Cooperation Agency (JICA), ASEAN Coordinating Centre for Humanitarian Assistance on disaster management (AHA Centre), and the Health Division of ASEAN Secretariat. The List of Participants appears in Annex 1.
- The Meeting was held to update and discuss the implementation of priority activities under the responsibility of PWG 1 within the ARCH Project Extension Phase. The agenda appears as Annex 2.

#### OPENING REMARK

3. Dr. Jirot Sindhvananda, Senior Adviser to Chulabhorn International College of Medicine, Thammasat University, as Chair of the Meeting delivered his opening remarks. He welcomed and appreciated the participants for allocating time for this meeting amidst their busy schedule. Dr. Sindhvananda also underlined the significance of initiatives and efforts made by PWG 1 of ARCH Project, including the Standard Operating Procedures for the Coordination of Emergency Medical Teams in ASEAN (ASEAN EMT SOP) and its of integration to the ASEAN Standard Operating Procedure for Regional Standby Arrangements and Coordination of Joint Disaster Relief and Emergency Response Operations (SASOP), and the ASEAN Collective Measures (ACM) for ASEAN Member States International-EMT which contains a number of important documents needed during health emergency response. He concluded by wishing for a fruitful and productive meeting.

#### UPDATES FROM THE ASEAN SECRETARIAT

4. The Meeting acknowledged the updates from the ASEAN Secretariat on several initiatives and efforts by the ASEAN Health Sector in responding to the COVID-19 pandemic, including new and on-going initiatives that contribute to strengthening future public health emergency preparedness with highlights on the establishment of the ASEAN Centre for Public Health Emergencies and Emerging Diseases (ACPHEED), the development of the framework and structure of the ASEAN Public Health Emergency Coordination System (APHECS), the implementation of project on Strengthening Regional Initiatives in ASEAN on COVID-19 Response and Other PHE. The Meeting also noted the outcomes from the Special Video Conference of ASEAN Health Ministers Meeting (AHMM) on COVID-19 held on 22 July 2021. The ASEAN Secretariat also shared the schedule of upcoming ASEAN Health Sector Meetings within the year of 2021. The presentation appears as Annex 3.

## UPDATES ON THE FINALIZATION OF EMT SOP AND INTEGRATION OF EMT SOP INTO ASEAN SASOP

- 5. The Meeting noted the updates from the ARCH Project Team on the progress on the endorsement of the revised ASEAN EMT SOP by ASEAN Health Cluster (AHC) 2 in April

2021. The Meeting also expressed appreciation to the efforts of the ASEAN Health Sector on the integration of the ASEAN EMT SOP into the ASEAN SASOP, particularly through the ongoing coordination with ASEAN Committee on Disaster Management (ACDM) and with the Disaster Management and Humanitarian Assistance Division of the ASEAN Secretariat, the transmittal of the revised EMT SOP to the ACDM Working Group on Preparedness, Response and Recovery (WG on PRR) for review and further testing in the next ASEAN Regional Disaster Emergency Response Simulation Exercise (ARDEX).

- 6. The Meeting was also informed on the cancellation of ARDEX in 2021 and 2022 as announced during the 15<sup>th</sup> Joint Task Force to Promote Synergy with other Relevant ASEAN Bodies on humanitarian assistance and disaster relief (JTF on HADR) meeting in July 2021. In light of this recent development, the following next steps were noted:
  - AHC 2 Chair Philippines together with ARCH Project Lead Country Thailand will attend the 2<sup>nd</sup> ACDM WG on PRR on 9 September 2021 to further discuss and explore ways forward in the integration of the ASEAN EMT SOP into ASEAN SASOP;
  - ACWG WG on PRR to elevate proposed ways forward to ACDM that will meet on 11-14 October 2021;
  - ASEAN Health Sector including the ARCH Project will be updated on the outcomes of the ACDM meeting in due course; and
  - Further progress will be reported in the next PWG 1 meeting
- 7. Taking into consideration that there was no decision on schedule of the next ARDEX, the Meeting was briefed that close coordination between AHC 2 and ACDM WG on PRR had being done through the facilitation of the Health Division and DMHAD of the ASEAN Secretariat. Based on this coordination, two recommendations might be surfaced and considered, namely: (i) the full integration of the ASEAN EMT SOP into ASEAN SASOP without the need for testing via ARDEX in consideration of the completion of the first step of the integration process through the conduct of the table top exercise (TTX) in November 2019, where there were minimal proposed revisions, or (ii) interim integration of the ASEAN EMT SOP subject to final testing through the next possible conduct of ARDEX.

The presentation appears as Annex 4.

#### UPDATES ON THE ASEAN COLLECTIVE MEASURES (ACM) FOR AMS I-EMT

- 8. The ARCH Project Team updated the Meeting on the substantive progress made by Sub-Working Group (SWG) on ACM through the development of a draft report on the ACM in the context of regional emergency medical response to disasters. The presentation covered in more detail the elaboration of sections regarding the (i) five ACM recommendations, (ii) challenges and analysis, (iii) management of ACM products, (iv) future status of the ACM, and (v) annexes of the report. The Meeting also expressed appreciation to the hard work by the ARCH Project Team and SWG-ACM in analysing the challenges and issues in emergency medical response, and for proposing recommendations and options for consideration of AMS.
- 9. The Meeting further noted the following points:
  - The set of recommendations and options that have been developed by SWG-ACM with the aim to address issues on logistics, customs clearance, medical waste management, medical malpractice and medical registration; as well as the supplementary tools, procedures or guidelines developed to address those issues;
  - There are challenges and gaps to complete the work on the ACM during the ARCH Extension phase until December 2021 and as such, priority activities to fully execute the recommendations will be carried out as part of ARCH Project Phase 2, and,
  - Proposal to continue the work of SWG-ACM in ARCH Project Phase 2, and the need to look into new critical issues that may need to be addressed in the next phase.

- The Meeting also discussed and exchanged views on several matters which were summarized as follows:
  - The need to review the term I-EMT which was based on the PWG 1 decision made in July 2019, with the consideration that this term may confuse with the WHO EMT Initiative. On the other hand, it was also pointed out that the term EMT is generally used by many response organisations regardless of the classification status by WHO. Therefore, Thailand suggested to replace the term I-EMT with AMS EMT and ASEAN Secretariat to also revisit the agreement during PWG 1 meeting in 2019;
  - Philippines expressed their concern that they may not be comfortable in sharing the information that they provided in the database of EMT; and rather suggested their view that the database, being a living document, should be maintained by each country and not openly accessed by all AMS;
  - It was underlined that the SOP and guidelines developed through the ARCH Project serve as reference for AMS to further formulate their national procedures and guidelines to complement the toolkit produced by the WHO EMT Initiative;
  - The need to consider the situation where receiving countries may have challenges in covering indemnification of medical malpractice of deployed EMT, taking into account NGO-managed EMT which may be in good number;
  - Reiteration on the aim of proposed collective measures to be used in assisting AMS in the development of EMT that can be deployed in compliance of WHO EMT standards through the cooperation between deploying and receiving countries;
  - In the further development of regional EMT capacity, it will be worthwhile to look into mechanisms where the affected AMS determine priority needs and gaps which can be covered by assisting AMS and hence having tailored arrangement based on the need and situation of receiving country;
  - Notation on proposal from Viet Nam to continue exchange of experiences of AMS in medical response in COVID-19 outbreaks and related matters such as COVID-19 vaccination roll-out.
- 11. As next steps, noting the endorsement of draft Report on the ACM, its recommendations, and annexes from the SWG-ACM via ad-referendum consultation between 13-24 August 2021, the Meeting agreed on the following:
  - PWG 1 Members will review and provide inputs to the draft report by 30 September 2021;
  - ARCH Project Team will finalise the report by November 2021; and,
  - PWG 1 Members will endorse the report at the next meeting in December 2021 as a product during the ARCH Project Extension Phase.

## PLANNED ACTIVITIES FOR THE ARCH RE-EXTENSION PHASE, AND UPDATES ON THE PREPARATION OF ARCH 2

- 10. The ARCH Project Team updated the Meeting on upcoming activities that will be implemented by both PWG 1 and PWG 2 in the remaining Period of the ARCH Project Extension Phase until December 2021, as well as on preparations for the implementation of ARCH Project Phase 2. It was noted that the last PWG 1 Meeting will be held in December 2021 to touch upon ARCH Project Phase 2 particularly the future strategies and priority activities under the PWG 1.
- 11. ## REPORT OF THE ONLINE PROJECT WORKING GROUP 2 CONFERENCE PROJECT FOR STRENGTHENING THE ASEAN REGIONAL CAPACITY ON DISASTER HEALTH MANAGEMENT (ARCH PROJECT)

22 March 2021, 1:00pm-3:00pm Bangkok Time

#### INTRODUCTION

- Chaired by Thailand as Lead Country of the ARCH Project, the Meeting was attended by representatives from Brunei Darussalam, Cambodia, Indonesia, Lao PDR, Malaysia, Philippines, Singapore, Thailand, and Viet Nam; the ARCH Project Team, Japanese Advisory Committee, Japan International Cooperation Agency (JICA) and ASEAN Secretariat. The List of Participants appears as <u>Annex 1</u>.
- 2. The Meeting discussed the implementation of initiatives under the ARCH Project Extension Phase particularly under the purview of Project Working Group (PWG) 2. The agenda appears as <u>Annex 2</u>.

#### OPENING REMARK

3. Dr. Narain Chotirosniramit, as the Chair of the Meeting, delivered opening remarks. He welcomed participants and highlighted the importance of ensuring continuation of progress and achievement of activities under the responsibility of PWG 2, including: the establishment of the ASEAN Academic Network and the ASEAN Institute for Disaster Health Management (AIDHM), the development of standard curricula for disaster health management, the conduct of the 5th Regional Collaboration Drill (RCD) and its preparation guidebook, and the publication of articles on ARCH and the conduct of ASEAN Academic Conference. Dr. Narain also wished a fruitful discussion that would guide the implementation of the said activities, therefore advancing disaster health management capacity in the ASEAN.

#### UPDATES FROM THE ASEAN SECRETARIAT

4. The Meeting noted the updates from the ASEAN Secretariat on the sustained and expanded ASEAN Health Sector's response to the COVID-19 pandemic, including initiatives for strengthening regional public health emergency preparedness. The update focused on (i) the establishment of the ASEAN Centre for Public Health Emergencies and Emerging Diseases, (ii) the development of ASEAN Public Health Emergency Coordination System (APHECS), (iv) the ASEAN-WHO-EU project on Enhancing regional coordination in response to COVID-19, (v) the Strengthening ASEAN's Capacities on Crisis and Health-Related Communication supported by GIZ. The ASEAN Secretariat also brief the Meeting on commitments of support from Dialogue Partners that were announced at 36th/37th ASEAN Summit and Related Meetings in November 2020; as well as the upcoming sectoral events that are relevant to the ARCH Project. The presentation appears as Annex 3.

## UPDATES ON THE TOR OF ASEAN ACADEMIC NETWORK AND ASEAN INSTITUTE FOR DISASTER HEALTH MANAGEMENT (AIDHM)

- 5. The Meeting noted the updates from the ARCH Project Team on the on-going consultation of the terms of reference (TOR) of the ASEAN Academic Network on Disaster Health Management (AANDHM) and ASEAN Institute for Disaster Health Management (AIDHM) at the level of the Regional Coordination Committee on Disaster Health Management (RCC-DHM), which elaborated on the proposed key revisions and their rationales on both TORs from the ad-referendum consultation conducted from December 2020 to March 2021. The presentation appears as Annex 4.
- 6. The discussion that ensued highlighted on the following:
  - Regarding the ASEAN Academic Network, the designated National Focal Points will be expected to define and agree on specific regulations or procedures, such as the duration of membership of institutions;
  - On the AIDHM and like most ASEAN centres, the host country is expected to bear the
    costs of the institute's secretariat, including human resources, office premises and its
    day-to-day operations. The financial contribution for the institute's programmes,
    including capacity building or training activities can be sought from other AMS and
    external partners.
- 7. On the ways forward, the Meeting further noted the recirculation of the revised draft TORs to RCC-DHM for final review and/or endorsement before subsequent elevation to AHC 2 Country Coordinators (CC) and Senior Officials Meeting on Health Development (SOMHD) Focal Points. The Meeting also agreed for PWG 2 Members to coordinate with their respective RCC-DHM Members, AHC 2 CC, and SOMHD Focal Points with the intention of facilitating and expediting internal reviews and/or endorsement of the TOR at each level.

## UPDATES FROM THE SUB-WORKING GROUP ON CURRICULUM DEVELOPMENT (SWG-CD)

- 8. The ARCH Project Team updated the Meeting on the progress of SWG-CD work on the development of two regional standard curricula, namely: Basic Disaster Health Management (BDHM) Course, and In-Country Course for the Coordination of EMT. The presentations appear as <u>Annex 5.</u>
- 9. The Meeting noted the brief updates related to BDHM Course, which focused on the (i) six course competencies which will be realized through a blended learning approach consisting of off-site individual study on the knowledge/theory and face to face workshop for joint application and skills development, (ii) the nine course modules, covering general disaster health management, medical medicine, and logistic-related topics, and (iii) progress of modules development and submission by AMS. While for the In-country Coordination Course for Coordination of EMT, the updated curriculum and changes of contents based on advice from PWG 2, specifically the reduction of course duration to four-days or 22 hours was also explained and acknowledged by the Meeting, as well as notation on the need to test the course as part of the conduct of the next RCD.

10. The Meeting also agreed for Lead Country Thailand and Cambodia to further discuss on contribution in the development of draft module materials and presentations for the BDHM Course. The Meeting further noted planned convening of the 3<sup>rd</sup> SWG-CD meeting, tentatively in late April or early May 2021 to finalise the course materials and contents, and to plan for the pilot-testing of the courses.

## UPDATES ON THE 5TH REGIONAL COLLABORATION DRILL (RCD) AND RCD PREPARATION GUIDEBOOK

- 11. The Meeting noted the updates from the ARCH Project Team on (i) the further rescheduling of the 5<sup>th</sup> RCD that will be hosted by Myanmar to 2022 considering the ongoing COVID-19 situation; and (ii) the progress on the development of the guidebook for RCD preparation. The presentation appears as <u>Annex 6.</u>
- 12. Regarding the conduct of 5th RCD, the Meeting agreed that the ARCH Project Team will provide further updates in the next PWG 2 online conference planned in July 2021. The Meeting also noted the outstanding tasks in the finalization of the guidebook, which include populating the annexes, creating 'must-read' sections, conducting a test run, completing the whole document, as well as subsequently circulating the guidebook for feedback and inputs for finalization at the next PWG 2 online conference.

## UPDATES ON THE PUBLICATION OF ACADEMIC ARTICLES ON ARCH AND THE PLAN FOR ASEAN ACADEMIC CONFERENCE

- 13. The ARCH Project Team updated the Meeting on the planned conduct of a three-day ASEAN Academic Conference tentatively in September 2021, with dates to be finalized during the next PWG 2 meeting. The event aims to facilitate discussions on emergency medicine and disaster health management, the experiences and lessons from AMS and Japan, the contributions of the ARCH Project to national policy and capacity development and to realising the One ASEAN One Response in disaster health management; and is designed as a combination of face-to-face conference in Bangkok and a virtual conference for overseas delegates. It is also envisaged that the first meeting of the ASEAN Academic Network Steering Committee will take place as a side event of the Conference. The Meeting further discussed that the final dates will be revisited and determined by COVID-19 situation in Thailand. The presentation appears as Annex 6.
- 14. The Meeting further noted the updates on the preparation of academic articles for publication in peer-reviewed journal specifically targeting Prehospital and Disaster Medicine International Journal by the University of Cambridge, including the schedule for publication and circulation of questionnaire as basis for writing an article on impact of ARCH Project on national disaster health management.

## PLANNED ACTIVITIES FOR THE ARCH RE-EXTENSION PHASE, AND UPDATES ON THE PREPARATION OF ARCH 2

15. The ARCH Project Team updated the Meeting on the implementation of endorsed activities during the remaining period of ARCH Re-Extension Phase (April – December 2021), and noted the progress in the preparation of ARCH Project Phase 2 that will be implemented

from 2022 - 2025. The Meeting further noted the framework, expected outputs and key activities of the proposed ARCH Project Phase 2 which will focus on policy, coordination, institutional and operational capacity, HRD, and research, as well as the ongoing project appraisal and approval process involving AHC 2, SOMHD and ASEAN Committee of Permanent Representative (CPR). The presentation appears as <a href="Annex 6.">Annex 6.</a>

- 16. The Meeting encouraged and enjoined the continued participation and support of all PWG 2 members and contact points of AMS in the finalization of consultations of the project proposal, and implementation of ARCH Project Phase 2 particularly on the conduct of RCD and peer-review activities, taking into account these responsibilities will be carried out by AMS and AIDHM after the completion of ARCH Project Phase 2.
- 17. Subsequently, the ARCH Project Team also provided a brief update on the on-going good practice documentation and sharing on COVID-19 response, with the potential holding of another webinar that will upcoming activity is an experience sharing by Singapore.

#### INTRODUCTION

- The Meeting was chaired by Thailand as the Lead Country of ARCH Project, and attended by Project Working Group (PWG) 2 members from Cambodia, Indonesia, Malaysia, Myanmar, Philippines, Thailand, and Viet Nam, as well as representatives from the ARCH Project Team, Japanese Advisory Committee, Japan International Cooperation Agency (JICA) and ASEAN Secretariat through the Health Division. The List of Participants appears as <u>Annex 1</u>.
- This Meeting discussed the implementation of initiatives under the purview of PWG 2 during the ARCH Project Extension Phase. The agenda appears as <u>Annex 2</u>.

#### **OPENING REMARK**

3. Dr. Narain Chotirosniramit, Director of Maharaj Nakorn Chiang Mai Hospital, as the Chair of the meeting started his opening remarks by welcoming all participants. He highlighted the progress and importance of activities under the responsibility of PWG 2 of ARCH Project, namely: the establishment of the ASEAN Academic Network on Disaster Health Management (AANDHM) and ASEAN Institute for Disaster Health Management (AIDHM) through the ongoing consultation of their terms of references (TORs), the development of standard curricula for disaster health management, Regional Collaboration Drill (RCD) guidebook, and publication of articles on ARCH Project and conduct of the ASEAN Academic Conference. Dr. Narain looked forward to a productive meeting and expressed his hope that the COVID-19 pandemic would end soon so that the group could scale up implementation of initiatives through face-to-face activities.

#### UPDATES FROM THE ASEAN SECRETARIAT

4. The Meeting acknowledged the updates from the ASEAN Secretariat on several initiatives by the ASEAN Health Sector in responding to the COVID-19 pandemic, with detailed explanation on the establishment of the ASEAN Centre for Public Health Emergencies and Emerging Diseases, the development of framework and structure for the ASEAN Public Health Emergency Coordination System (APHECS), the implementation of project on Strengthening Regional Initiatives in ASEAN on COVID-19 Response and Other Public Health Emergencies, among others. The Meeting also noted the outcomes from the Special Video Conference of ASEAN Health Ministers Meeting on COVID-19 held on 22 July 2021. Subsequently, the ASEAN Secretariat also briefed the Meeting on upcoming ASEAN Health Sector meetings until the end of 2021. Related to the presented initiatives, it was reaffirmed that the ARCH Project has been viewed to be contributing to regional response to emergencies and will be engaged in consultations in the development of APHECS. The presentation appears as Annex 3.

UPDATES ON THE TOR OF ASEAN ACADEMIC NETWORK ON DISASTER HEALTH MANAGEMENT (AANDHM) AND ASEAN INSTITUTE FOR DISASTER HEALTH MANAGEMENT (AIDHM)

The ASEAN Secretariat provided updates on the status of consultation of the TOR of the ASEAN Academic Network on Disaster Health Management (AANDHM) and ASEAN Institute

for Disaster Health Management (AIDHM) which were being reviewed by the ASEAN Health Cluster (AHC) 2 on Responding to All Hazards and Emerging Threats, and the Regional Coordination Committee on Disaster Health Management (RCC-DHM), respectively.

- 6. The Meeting also took note of the summary of amendments on both TORs, and the next steps in the consultation process. The Meeting further noted that prior to the further consultations on the TOR of AIDHM, the host country has been recommended to be determined at the level of RCC-DHM in consideration of the expressions of interest made by RCC-DHM Indonesia and Thailand through e-mail consultation. In this regard, the following steps were shared:
  - ASEAN Secretariat will communicate with RCC-DHM Chair and Secretariat on the outcome of consultation among ASEAN Member States, through the RCC-DHM, on the expression of interest to host the Institute, and the possible steps in determining the host country:
  - Interested AMS to be requested to formalize their expression of interest via letter from Senior Officials, and specify their detailed plans on the Institute's establishment, operations and sustainability, as guided by the draft TOR;
  - RCC-DHM to discuss and determine the host country through consensus, and which
    may involve: (i) initial meeting to discuss and agree on the selection process, (ii)
    bilateral discussion between interested AMS, and (iii) follow-up meeting to further
    discuss on the results of the bilateral discussion, and agree on host country decision;
    and.
  - The host country decision and draft TOR will be elevated to AHC 2 and SOMHD for further review and endorsement.

The presentation appears as Annex 4.

### UPDATES FROM THE SUB-WORKING GROUP ON STANDARD CURRICULUM DEVELOPMENT (SWG-CD)

- 7. The ARCH Project Team reported to the Meeting on the progress of the development of Basic Disaster Health Management (BDHM) Course and In-Country Course for the Coordination of EMT as conducted by SWG-CD, as well as revisited the general information about both courses including the overview, objective, competencies, and module structure.
- 8. Following the 3<sup>rd</sup> SWG-CD meeting in July 2021 where all modules were reviewed and proposed revisions were made, the Meeting noted the next steps in the development of BDHM Course including the need for the conduct of additional SWG meetings to finalise the modules' contents based on received inputs, develop workshop materials, conduct of pilot trainings, as well as the need for external reviewers and editors. The Meeting also agreed to elevate the training outline to the AHC 2 and SOMHD for endorsement, in parallel to the finalization of detailed training materials.
- Regarding the In-Country Course for Coordination of EMT, the ARCH Project Team
  informed the Meeting on the plan to finalize the session plans and the development of session
  materials, as well as identification of resource persons as the next steps for the development
  of this particular course.
- 10. The Meeting agreed to further consult and coordinate with WHO to obtain recognition of both training courses, which have been developed based on WHO guidelines, templates, and materials. Relatedly, potential support in capacity building and practical recommendation could also be further explored with WHO.

The presentation appears as Annex 5 and 6.

#### UPDATES ON THE RCD GUIDEBOOK DEVELOPMENT

- 11. The Meeting noted the update from the ARCH Project Team on the development of Guidebook for Preparation of RCD with major updates including the completion of the main body, the finalization of annexes, and the depository of the materials that is already made available.
- 12. The ARCH Project Team also explained the way forward after the guidebook finalization, namely: the conduct of trials for usability check, the incorporation of advice from mentor teams, and the further discussion on the long-term depository mechanism and related resources including the possibility to utilize the AIDHM for the purpose. The PWG 2 agreed to make a final review of the guidebook until 30 September 2021 prior to the finalization.

The presentation and draft guidebook appear as Annex 7 and 8, respectively.

### UPDATES ON THE PUBLICATION OF ACADEMIC ARTICLES ON ARCH PROJECT AND PLANS FOR ASEAN ACADEMIC CONFERENCE

- 13. The ARCH Project Team updated the Meeting on the publication of five peer-reviewed articles on ARCH in a supplemental issue of an international journal, the Prehospital and Disaster Medicine (PDM). The Meeting further noted the engagement of 43 persons as contributing authors of the articles, guided by an advisory working group consisting of academic experts from Thailand and Japan.
- 14. The PWG 2 also noted the plan for the conduct of an ASEAN Academic Conference to be tentatively held on 1-2 December 2021 through virtual platform. The Meeting was further informed on the conference's main theme on How can ASEAN release the "One ASEAN One Response" in the field of disaster health management, as well as discussed the target participants, the agenda that comprises of four sessions and one panel discussion, and guideline for presentation. The Meeting agreed to review and provide inputs and/or endorsement to the draft conference's concept note by 15 September 2021, which will further enable the ARCH Project Team to proceed with actual preparations.
- 15. The Meeting also noted the proposed schedule of a Preparatory Meeting of the AANDHM to be conducted prior the Academic Conference on 30 November 2021 to be attended by representatives of potential/candidate National Focal Points (NFP) from AMS. The meeting aims to confirm the TOR and next steps towards the actual establishment of the network. The PWG 2 members also agreed to initiate internal discussions within their respective offices for the identification of NFP for AANDHM based on the TOR, anticipating that NFP could be identified and could attend the Preparatory Meeting. If NFP nomination has not been decided, the Meeting was informed that, based on the draft TOR, representatives from RCC-DHM may attend the Preparatory Meeting as ad-interim NFP.

The presentation and concept note appear as Annex 9 and 10, respectively.

### PLANS FOR THE IMPLEMENTATION OF ACTIVITIES IN THE REMAINING PERIOD OF THE ARCH PROJECT RE-EXTENSION PHASE, AND UPDATES ON THE PREPARATION OF ARCH PROJECT PHASE 2

16. The ARCH Project Team updated the Meeting on planned activities for the remaining period of the ARCH Re-extension Phase, and on preparations for the implementation of ARCH Project Phase 2. The updates included the progress of major activities and respective ways forward with highlight on the postponement of 5th RCD to ARCH Phase 2 due to travel restrictions resulting from COVID-19 pandemic; and calendar of activities during the remaining period where the last PWG 2 meeting during the ARCH Project Extension Phase is planned

in December 2021 to discuss and agree on strategies and priority activities for ARCH Project Phase 2.

17. The Meeting also acknowledged the ARCH Project Phase 2 project framework which is to be implemented from January 2022 to March 2026. including its overall goal, outputs, verifiable indicator, major events and activities, and implementation structure. The PWG 2 members agreed to continue their support in the implementation of ARCH Project Phase 2.

# THIRD MEETING (ONLINE) OF SUB-WORKING GROUP (SWG) ON CURRICULUM DEVELOPMENT 15-16 July 2021

### **SUMMARY AND WAYS FORWARD**

### 1. Summary of Minutes of the 2<sup>nd</sup> Meeting of Sub-Working Group on Curriculum Development

The Meeting noted the summary of discussions, agreements, and ways forward of the 2<sup>nd</sup> Meeting of SWG-CD conducted in September 2020, as well as the progress of these agreements and ways forward.

### 2. Presentation of draft modules for the Basic Disaster Health Management Training Course (B-Course)

- The Meeting expressed appreciation to members of SWG-CD for their commitment to the ARCH Project through the drafting of articles of the different modules (following the agreed template) that constitute the B-Course, as well as the corresponding PowerPoint materials used to present the modules.
- The Meeting noted the modules and their content as presented by preparers, and thereafter exchanged general views and feedback, which are outlined below (Note: For feedback and recommendations on specific module, please refer to relevant module section):
  - As target training participants are domestic/national responders, simplify terms throughout the document (including title); prioritise which information to be included in each article and provide links for relevant further reading
  - As regional standard training course, lessons learned sections are anticipated to be more general and country-specific experiences can be supplementary (such as on module 2 by Indonesia)
  - Module preparers to coordinate with other preparers to discuss and agree which aspects of module contents to cover to reduce overlaps and duplication
  - Include a module overview at the
  - SWG-CD members can further share feedback and suggestions by e-mailing the ARCH Project Team and preparer of specific module articles
- The Meeting noted the summary of comments and feedback on the B-Course. The Meeting also exchanged views, which key points are summarized as follows:
  - SWG-CD members to revise and update the modules/articles based on general and specific inputs from the Meeting;
  - ARCH Project Team to consult with Brunei Darussalam, Indonesia and Viet Nam to discuss on content that are included in the modules they are developing and agree on which content belongs to which module in order to reduce overlaps and duplication;

- An overall course development coordinator/chief editor may need to be identified to go through all the modules to ensure there is no unnecessary duplication and critical topics are covered, and language used are simplified and harmonized.
- While the module articles are being finalised and facilitator guides are developed, the SWG-CD can already elevate the course curriculum/training outline for review and/or endorsement by the ASEAN Health Sector.
- The ARCH Project Team will further communicate with SWG-CD on these matters.

### 3. Review of draft Modules of In-Country Coordination Course (C-Course)

- The Meeting noted the updates from the ARCH Project Team on the status of further development of the course, specifically on the session plans, materials, and resource persons. The Meeting also noted the following:
  - The four-day course will cover international and regional mechanisms and methodology in the first three day, while the fourth day will dedicate on the application of concepts at the local/national level. The further development of the course to consider the balance between international and regional methodologies, and national mechanisms and methodologies. AMS implementing the course are expected to adapt the course contents according to their context.
  - The priority of the ARCH Project Team now is the further development and finalisation of the session plans, the identification of resource persons to be part of the course implementation team, and development of session materials.
  - The ARCH Project includes the conduct of trainings for ASM as part of the regional collaboration drills, as well as the conduct of a course for trainers to develop a regional pool of resource person who will be responsible leading in-country trainings.
  - The development of pre-reading materials is still being discussed considering perceived challenges in preparing material for a diverse. Nevertheless, the team may proceed by working with RCD host country in the development of the pre-reading materials, by following the process of developing pre-reading materials applied by B-Course.
  - The ARCH Project Team may need the support of AMS resource persons in the development of the pre-reading materials; it will internally discuss and communicate with the SWG-CD.

### 4. Discussion on Workshop for B-Course

- The Meeting noted the presentation on the methods in the delivery of the course modules, such as group discussions, hands-on simulation practice, integrative workshop/table-top exercise, among others. The Meeting also noted the request of the ARCH Project Team for inputs from SWG-CD in the identification and development of scenarios that will be bases in the further development of the training methods.
- The Meeting agreed that the ARCH Project Team will propose a detailed template for the
  development of session plans, as well as scenarios that will be used in the development of
  these plans, which will be presented to SWG-CD for their feedback. The ARCH Project
  Team will further communicate on the matter in due course.

### **SUMMARY AND WAYS FORWARD**

### MINUTES FROM THE 3RD SWG CD

1. <u>Noted</u> the summary of agreements and ways forward from the Third Meeting of the Sub-Working Group on Curriculum Development conducted on 15-16 July 2021.

#### BASIC DISASTER HEALTH MANAGEMENT COURSE

- 2. <u>Noted</u> the updates from the SWG-CD Secretariat on the progress on the revision of modules since the last meeting (July 2021), as well as the on-going review of the modules to ensure harmonised and simplified language and to eliminate unnecessary duplication.
  - <u>Agreed</u> that SWG-CD Members will work with assigned editors in the finalisation of the modules.
- 3. <u>Noted</u> **the proposed workshops (course methods)** to facilitate development of manual, application and appraisal skills, team management and integrated skills through the course.
- 4. Noted the proposal of the ARCH Project Team to revise the duration of the Basic DHM Course from five to three days by integrating the table-top and two field exercises into one 'putting it all together' exercise (table-top exercise) and after-action review and discussion.
  - <u>Agreed</u> on the proposed revised the Basic DHM Course which is more concise, feasible and manageable;
  - Exchanged views which points are summarised as follows:
    - There should be pre-requisites for course participants given their various background, experience and knowledge

- o Consider a mix of learning methods which will make the course more attractive
- Consider more interactive methods with more visualization, such as pictures or infographics
- Recommend specific workshop methods in the delivery of the revised course modules, while also considering local context and practices
- Prepared modules can be used as pre-reading materials or further developed into pre-recorded lecture or sessions which will be fulfilled by each participant before attending the course; this is to achieve a level of understanding among participants
- Consider an assessment on the pre-reading materials and pre-course exercises conducted before participants attend the course
- Some AMS may consider pre-course sessions to cover national disaster management systems and mechanisms to level off understanding of participants who come from various backgrounds
- Ensure proper referencing of published materials and articles cited in the modules
- <u>Further noted</u> that the changes in different modules and workshops will be finalised and consolidated into a document, and which will be presented in the next SWG-CD meeting.
- 5. <u>Noted</u> **the proposed workshops (course methods)** to facilitate development of skills categorised into manual, application and appraisal; team management; and integrative skills, through the course.
- 6. Further noted the following:
  - The proposed methods, equipment/materials needed, instructor/facilitator needs and processes of the workshops (course methods), such as group discussions, hands-on exercises, games, and tabletop exercise/integrative workshop, that will be used in delivering the modules.
  - The proposed expected outcomes and answers from the workshops that will guide instructors and facilitators in assessing participants and teams
  - The importance of the development of a well-designed scenario for the integrative workshop, which serves as the main assessment process of the course.
  - The example forms and documents that may be used by participants/teams in responding to the games and exercises
  - The ICS game seems to be complicated, and may need to explore how to access reference materials (videos) that will guide instructors and facilitators in learning and in executing the game.
  - The SWG-CD Secretariat Team will compile proposed/available scenarios for the different workshops, and will share them to SCW-CD Members for review, feedback and further recommendations.

- 7. Noted that the SWG-CD Secretariat Team is finalising a draft workshop instruction manual which outlines all workshops (course methods) for the different modules. Further noted that a mock-up course is proposed to be conducted in Q3/2022 to test and review the manual and other course materials with the involvement of trainers from AMS.
- 8. Exchanged views which points are summarised as follows:
  - Include a non-disaster-related ice-breaking or getting-to-know session before the start of the course, which method is observed to be mostly discussions and interaction among participants.
  - In the adaptation of the course materials, the translation of materials into national and local context and language may be considered.
  - AMS trainers participating in the mock-up course may be able to provide further insights into the course adaptation and roll-out in their respective countries. The ARCH Project may be able to support follow-up activities at the national level.
  - To maintain the ASEAN-flavour of the courses and capture various experiences from AMS, SWG-CD may consider identifying a repository of training reviews and documentation which can be accessed by other AMS.
- Agreed that the SWG-CD Secretariat will prepare and share a timeline of activities to finalise the course materials leading to the conduct of a mock-up course, for reference of the SWG-CD.

### **IN-COUNTRY COORDINATION COURSE**

10. <u>Noted</u> the updates from the SWG-CD Secretariat Team on the course framework, formulation and implementation plan, including the preparation of all key session plans, the development of session materials, and identification of resource persons for the four-day course.

### 11. Further noted the following:

- The pre-course learning/component is proposed to be developed by each AMS in consideration of variances in coordination processes at national and local levels. Nevertheless, the pre-course may focus on information gathering and decision making, how-to-situational assessment, mobilisation of N-EMT (or local partners) and of I-EMT (or EMT from other AMS)
- The proposed merger of related modules, i.e. Module 1 on Course Introduction and Module 2 on Orientation to the Course, and Module 19 on Exit Strategy and Demobilisation and Module 20 on Considerations in Transition (while consider including Logistics for Coordination, and Experience Sharing such as from Japan DMAT)
- The course can be implemented as a stand-alone course, or a course given to the host of the RCD as preparation for the organisation and delivery of the drill

- It is envisaged that eventually each AMS will have trainers/resource persons to deliver the In-Country Coordination Course
- The suggested profile of participants and process of selection, including the compulsory and preferred prerequisites for participants, will be the final decision of AMS
- The selection of experts who will be involved in the preparation of session materials in December 2021 and January 2022, the preparation of session materials in Q2/2022, and the conduct of a mock-up course in Q4/2022
- 12. Exchanged views which points are summarised as follows:
  - The course will integrate country-specific information into the pre-reading materials to capture national-level mechanisms; the development of pre-reading materials are part of the priorities in 2022
  - The delivery of the course may be context specific and be based on practical considerations, taking into consideration the technical expertise available in some countries among others
  - Consider a second tier where AMS experts can be a resource of trainings of other countries, particularly those with recent response experiences
  - The ASEAN Collective Measures will be a valuable reference in the further development of the C-Course as well as in the development of protocols for receiving I-EMT
  - The consideration of identifying resource persons that will cover international/ regional as well as national/domestic/local mechanisms and arrangements
  - To refer to emergency coordination training materials produced by AHA Centre for the further development of modules related to ASEAN disaster management mechanisms.

### PROJECT STRATEGY FOR TRAINING PROGRAMMES UNDER ARCH 2

13. <u>Noted</u>, as part of ARCH 2 (2022-2025), the regional trainings that are scheduled to be undertaken in Thailand and Japan for the purpose of training trainers, networking, testing of modules of courses prepared through SWG-CD, and conduct of emerging issues such as on public health emergencies.

### 14. Further noted the following:

- Detailed implementation plan for training activities in 2022
- ARCH 2 can also support the conduct of the two courses at national level, through advise on curriculum/teaching materials, development of implementation plan and dispatch of lecturers
- ARCH Project to consider the possible delivery of some of the courses via virtual platform

• While the peer review study/activity in Thailand will involve all AMS, the succeeding studies in other countries may only involve three countries. The latter will be further discussed in the next PWG 2 meeting.
