- + Na Phat A village, Na Son commune.
- + Na Phat B or C village, Na Son commune.
- + Tia Ghenh C village, Keo Lom commune.
- => Opinions of District PMU members:
- Dien Bien district:
- + Agreed to select Sai Luong village, Nua Ngam commune
- + Replace Pu Tiu 13,14 village by Phieng Ban village. Because: Pu Tiu village is located in area planned [to be developed] by district. In the near future, forest area of the village will be changed a lots.
- Dien Bien Dong district:
- + Agreed to select 3 villages: Na Phat A village, Na Son commune; Huoi Mua (instead of Na Phat B or C) and Tia Ghenh C villages, Keo Lom commune.
- + Replaced Nam Ngan village, Pu Nhi commune by Hang Tro B village. Reason: Nam Ngan villagers are moving to other place, because of electric plant construction.
