GENERAL PROVISIONS

- Subject of application

This Decree applies to government organizations, agencies, public and private entities, households and individuals operating in the territory of the Socialist Republic of Vietnam **engaged in activities to emit GHG and/or efforts to reduce GHG emissions.**

GENERAL PROVISIONS

- Scope of regulation

This Decree shall provide detailed guidance for principles, authority, and administrative procedures and modalities, responsibilities of regulatory and implementing entities, organizations, and individuals in development, implementation, management, monitoring of programs and projects to reduce greenhouse gas emissions **during the period 2021-2030** in Vietnam in the context of GHG emission reduction target of the **Nationally Determined Contribution (NDC)** along with **vision to 2050**.

ROADMAP FOR GHG EMISSION REDUCTION IN VIETNAM

1. Pre-2020

- Establishment of national system for GHG inventory, MRV and registration of all level;
- Planning and piloting NAMAs;

2. From 2021 to 2030

- To implement sectoral GHG mitigation options: energy, agriculture, waste and LULUCF to achieve NDC's target.

3. From 2030 to 2050

- Long-term Low Emission Development planning with vision to 2050.
 - Analysis to project long-term GHG emission pathway including possible peaking of GHG emission.

 - **Fund mobilization and International Cooperation**
 - **Management for GHG emission reduction**

COORDINATION FOR IMPLEMENTATION OF THE DECREE

- **Guiding principles**
 - **National coordination arrangement for implementation of GHG emission reduction**
 - a) *Direction and common modality for basic researches and assessments;*
 - b) *Mitigation planning and mitigation target setting;*
 - c) *Modality for integrating GHG emission reduction into development planning;*
 - d) *Reporting progress of implementation of GHG emission reduction;*
 - e) *Validation of reported emission reduction amount; and*
 - f) *Conflict resolution among stakeholders in the context of implementing GHG emission reduction.*
