istrict, Hanoi • Joint Coordination Committee (JCC):

The JCC with twelve (12) members headed by Dr. Võ Tuấn Nhân, Vice-Minister of MONRE is responsible to facilitate interorganizational coordination.

• Project Management Unit (PMU):

The PMU shall manage all the activities of the Project and report to JCC about the important issues.

Dr. Mai Thanh Dung, Deputy Director General of VEA holds the position of the National Project Director

· Task Force (TF):

The TF is established to review and examine the pilot project activities and coordinate inter-provincial issues.

Main purpose of the "TF" is to ensure effective technical transfer and report to the PMU about the activities of pilot projects and issues occurred at river basin level.

Working Group (WG):

The WG is established in each target province to conduct the pilot projects and coordinate inner-provincial technical The WG shall report the results of the pilot project to TF and PMU.

The Pilot Project

Related to the Pilot Project activity, Shortterm **Expert** Team (SET) commenced Subcontract Works and Initial Capacity Assessment.

Subcontract Works

SET is conducting subcontract works on Pollution Source Inventory in both river basins. Interim Reports of these subcontract work will be prepared in this August.

TORs for other subcontract works are now being prepared and they will be started sequentially from next SET assignment period.

Initial Capacity Assessment

The initial Capacity Assessment (CA) has conducted cooperation been with MONRE/VEA, mainly ESI & WENID, and the concerned DONREs.

Based on the result of the initial CA, the detail capacity development plans will be prepared and carried out, as a part of the Pilot Projects.

Development of Draft Circulars

Among the six target circulars of the project, one circular on compensation for environmental damages is on the way of finalization.

Compensation Circular

The Project is cooperating with the VEA side to develop the circular on guiding format and procedure of requesting environmental compensation for natural environment damages. The first draft of Circular has been completed.

During the development of the Circular, Site Surveys were conducted in Thanh Hoa and some provinces of the South in order to:

1. Review and study about previous case studies, which were resolved by local authorities, to complete shortcomings encountered during the development of circular; 2. Verify the applicability of some provisions in the draft Circular

In additions to the publication of the draft Circular on the website, workshops shall also be organized to get more comments about the Circular. The Circular shall be promulgated in this year as required by MONRE.

Other target Circulars

The other target Circulars shall be subject to legal document review conducted at the central level and pilot projects at the provincial levels.

Review of the current legal system in Vietnam

The aim of this activity is to identify the current problems and constrains, especially in real execution occasions; to decide overall directions for developing the Circulars; to propose improvement measures; and to reflect review results for preparation of the four target including Circular/regulation circulars. mechanism: Circular coordination on assessment of loading capacity and estimation of discharge permit; Circular on wastewater discharge sources; and Circular on information sharing and disclosure system.

Currently, the TORs for review of the current legal system have been confirmed by JICA side and VEA side; and the contracts with consultants shall be signed soon.
