Living Conditions

Egypt is the most populous country in the Middle East and the third-most populous on the African continent (after Nigeria and Ethiopia). Majority of the population in Egypt is concentrated on the fertile banks of river Nile, especially in Alexandria and Cairo, within the Delta and the Suez Canal. Most of the country is desert, so about 95% of the population is concentrated in a narrow strip of fertile land along the Nile River, which represents only about 5% of Egypt's land area. Egypt's rapid population growth – 46% between 1994 and 2014 – stresses limited natural resources, jobs, housing, sanitation, education, and health care

Egypt has a very young population 75% of whom are under the age of 25 and just 3% are over the age of 65. Greater Cairo has an older population compared to the national average, however, with 36% of the population under the age of 15. Cairo, the capital of Egypt has the highest population density (2136.1 person per sq km against 63.7 person per sq km). While the 2016 population of Cairo is 12 million, the Greater Cairo area has over 20 million people. In addition, Egypt has six of the world's wealthiest people, according to Forbes' list of richest people in the world; 90% of whom are living in Greater Cairo. People of Egypt comprise different ethnic groups. Egyptians comprise of 98% of the total population. Bedouin, Nubian and Beja cover only 1% among the population. Rest of the 1% of population is comprised of the Europeans mainly of French and Italian origin. Armenians and Greeks also form part of the population.

The religion of population of Egypt is mainly Islam. Muslims dominate 90% of the total population, most of which are Sunni Muslims. Egyptian Christians, nearly all of whom are Copts (adherents of the Coptic Orthodox Church or other Coptic churches), most likely account for about 10% of the population. The Current male population is 50.2% while the female population is 49.8%, which is lower than the global sex ratio. Equality of the sexes is provided by law, but many aspects of law and traditional practice discriminate against women.

Organizational Context & Project Description

The World Food Programme (WFP) is the world's largest humanitarian agency, fighting hunger worldwide. With its new Strategic Plan (2017-2020), WFP will increasingly provide technical support to governments to strengthen their national safety net programmes and social protection systems. This will include but not be limited to WFP's support to safety nets and education through school feeding, as a key part of many national social protection strategies.

The School Feeding unit within WFP's Programme in Regional Bureau in Cairo (RBC) provides support to country offices implementing school feeding in support of education and providing technical assistance to national school meals programmes and other safety nets for scale-up, increased efficiency and handover.

The unit seeks an experienced candidate able to support WFP RBC in its effort to: a) position school meals as an intervention contributing to education and social protection outcomes in countries and support improved efficiency, effectiveness of selected school meals programmes and transition to ownership; b) broaden the understanding of the role of school meals in contributing to education outcomes and especially to education in emergencies, and related strategic partnerships; and c) strengthen strategic partnerships relevant to school feeding and develop wider knowledge of innovative approaches and solutions.

Task description

Under the direct supervision of the Programme Advisor, School Feeding Unit, the UN Volunteer will undertake the following tasks:

Support the team to broaden the understanding and knowledge of the role of school feeding in contributing to education social protection and other outcomes, especially in emergencies;

Participate to the elaboration of different reports and analysis building evidence on school feeding in emergency and protracted crisis as well as education and social protection;

Synthetize available evidence and lessons learnt on a School Feeding; and develop a master sheet database;

Support the team with the draft of key documents and communication material to sustain an active and fruitful participation in multiple education related for a such as Local Education Groups (LEGs), Global Partnership for Education (GPE), SDG 4 Arab region working group, Education Can't Wait, No Lost Generation, Life Skills and Citizenship Education Regional Initiatives.

Liaise with the local JICA office to seek possibilities of collaborative activities between WFP and JICA in line with IFNA (Initiative for Food and Nutrition Security in Africa), SHEP (Smallholder Horticulture Empowerment and Promotion), CARD (Coalition for African Rice Development) and education (incl. pre-school education) programs, where appropriate.

In addition, the UN Volunteer will support the team to explore innovative approaches and ideas which are already existing outside, to build on existing best practices in the region and to share knowledge acquired:

Research reports and relevant information on school meals programmes produced by major partners, such as the World Bank, USAID, INGOs, and other UN partner agencies (UNICEF, UNESCO, FAO).;

Research, collect and consolidate lessons learned and best practices from RBC region on Early Childhood Development (ECD), adolescents and youth, school feeding programmes' contribution to peace, life skills and citizenship education, etc Research, collect and consolidate lessons learned and best practices from RBC region on WFP school feeding programmes for knowledge management and sharing;

Support the dissemination of relevant material and information by drafting newsletter, articles and additional documents and internal capacity building activities that could be shared both internally and externally.

The contract lasts for the period indicated above with possibility of extensions subject to availability of funding, operational necessity and satisfactory performance. However, there is no expectation of renewal of the assignment.

A UN Volunteer receives a Volunteer Living Allowance (VLA) which is composed of the Monthly Living Allowance (MLA) and a Family Allowance (FA) for those with dependents (maximum three).

The Volunteer Living Allowance (VLA) is paid at the end of each month to cover housing, utilities, transportation, communications and other basic needs. The VLA can be computed by applying the Post-Adjustment Multiplier (PAM) to the VLA base rate of US\$ 1,651. The VLA base rate is a global rate across the world, while the PAM is duty station/country-specific and fluctuates on a monthly basis according to the cost of living. This method ensures that international UN Volunteers have comparable purchasing power at all duty stations irrespective of varying costs of living. The PAM is established by the International Civil Service Commission (ICSC) and is published at the beginning of every month on the ICSC website http://icsc.un.org.

In non-family duty stations that belong to hardship categories D or E, as classified by the ICSC, international UN Volunteers receive a Well-Being Differential (WBD) on a monthly basis.

Furthermore, UN Volunteers are provided a settling-in-grant (SIG) at the start of the assignment (if the volunteer did not reside in the duty station for at least 6 months prior to taking up the assignment) and in the event of a permanent reassignment to another duty station.

UNV provides life, health, permanent disability insurances as well as assignment travel, annual leave, full integration in the UN security framework (including residential security reimbursements).

UN Volunteers are paid Daily Subsistence Allowance at the UN rate for official travels, flight tickets for periodic home visit and for the final repatriation travel (if applicable). Resettlement allowance is paid for satisfactory service at the end of the assignment.

UNV will provide, together with the offer of assignment, a copy of the Conditions of Service, including Code of conduct, to the successful candidate.

Supervision, induction and duty of care of UN Volunteers (Roles and Responsibilities of Host Entities)

UN Volunteers should be provided equal duty of care as extended to all host entity personnel. Host entity support to the UN Volunteer includes, but is not limited to:

- Introductory briefings about the organisation and office-related context including security, emergency procedures, good cultural practice and orientation to the local environment;
- Support with arrival administration including setting-up of bank accounts, residence permit applications and completion of other official processes as required by the host government or host entity;
- Structured guidance, mentoring and coaching by a supervisor including a clear workplan and performance appraisal;
- Access to office space, equipment, IT support and any other systems and tools required to complete the objectives of the assignment including a host entity email address;
- Access to shared host entity corporate knowledge, training and learning;
- Inclusion of the volunteer in emergency procedures such as evacuations;
- Leave management;
